- -Isolation Valve on Riser fitted with supervised devise appears to be in closed position.

Hello All,

Thanks for addressing this hazard in your district. I support Chief Hunter's direction to mitigate the immediate hazard and schedule a follow up for the issues of trash and the alarm system. This is an example of code violations that can be managed at the company level by Operations, until the time when more Code Inspectors are available to address these properties.

An prompt re-visit to the property by Station 15 is necessary. Instruct the responsible party to remove the trash and give an reasonable amount of time to repair the alarm system; 30 days is appropriate. If upon a reinspection in 30 days the violations are not being dealt with, then you can notify me and/or Assistant Fire Marshal Cesar Avila and we will get the appropriate District Code Inspector involved.

Also, in the future, when you determine a referral to the Fire Prevention Bureau is necessary, please try to include contact information for a manager, or property owner, if you have been able to obtain it.

More guidelines will be shared with all Suppression personnel in the near future. In the meantime, thanks very much for your persistence in this matter, and hard work in general.

There are no fire extinguishers. Storage in the hallways. Faulty or unmaintained smoke detectors. These issues are on the first floor. You can refer to Captain Chews emails for violations on the floors above.

This building is dangerous!

Please let station 15 know what we can do to get this place shut down, updated and repaired.

One possibility is get the city attorney involved in the same manner as 641 West Grand. That building was in bad shape but it is now on the road to recovery. (slowly)
