

CIRQUE VOLTA SWEEPSTAKES - 2018

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Live Nation, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY

Open only to legal residents of California, 18 years of age or older and must be in the ABC7 KGO-TV viewing area as defined by the A.C. Nielsen Company (Alameda, Contra Costa, Lake, Marin, Mendocino, Napa, San Francisco, San Mateo, Santa Clara, Solano & Sonoma counties).

Go to <http://abc7news.com/contests/> and complete an Official Entry Form. You must include your first and last name, complete address, day and evening telephone numbers, date of birth and e-mail address. You may enter once every 24 hours through the duration of the Sweepstakes.

One (1) winner will be chosen to receive dinner for two (2) and a pair (2) of Cirque VOLTA tickets.

Dinner for two is valued at \$150.00. Prize will be given in gift card form to Atwater Tavern, in San Francisco.

Cirque VOLTA show tickets are valued at \$230.00 for the pair.
