

# CIRQUE VOLTA HOLIDAY SWEEPSTAKES - 2018

## Official Rules

### **I. NAME OF SPONSOR & ADMINISTRATOR**

Live Nation, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."
