# "Alaska Airlines Flyaway Promotion"

## **Official Rules**

#### I. NAME OF SPONSOR & ADMINISTRATOR

Alaska Airlines, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

#### II. ELIGIBILITY

## **ARV of each First Place Prize: \$80**
