

"Aulani, A Disney Resort and Spa Sweepstakes Promotion"
Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Disney Resort and Spa, hereafter referred to as "prize provider."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY
