

THE 51ST ANNUAL CMA AWARDS SWEEPSTAKES - 2017

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

CMA Awards, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY
