

# **“DISNEYLAND MAIN STREET ELECTRICAL PARADE SWEEPSTAKES ” - 2017**

## **Official Rules**

### **I. NAME OF SPONSOR & ADMINISTRATOR**

Disneyland hereafter referred to as “Sponsor.”

ABC7 KGO-TV, hereafter referred to as “Administrator.”

### **II. ELIGIBILITY**

Open only to legal residents of California, 18 years of age or older and must be in the ABC7 KGO-TV viewing area as defined by the A.C. Nielson Company (Alameda, Contra Costa, Lake, Marin, Mendocino, Napa, San Francisco, San Mateo, Santa Clara, Solano & Sonoma counties).
