

# "Disney On Ice Presents Let's Celebrate" Sweepstakes

## Official Rules

### **I. NAME OF SPONSOR & ADMINISTRATOR**

Feld Entertainment, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

### **II. ELIGIBILITY**
