

# "Disneyland 60<sup>th</sup> Anniversary 2015 Sweepstakes"

## Official Rules

### **I. NAME OF SPONSOR & ADMINISTRATOR**

Disneyland Resort, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

Winner will be notified by phone and/or e-mail.

Odds of winning depend on the number of eligible entries received.

Drawing will be conducted by Administrator. By participating, entrants agree to the Official Rules and the decisions of the Administrator, which shall be final and binding in all respects.
