

# "Guglielmo Winery 90<sup>th</sup> Anniversary Gala" Sweepstakes

## Official Rules

### **I. NAME OF SPONSOR & ADMINISTRATOR**

Guglielmo Winery, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."
