

'HONEYBAKED SWEEPSTAKES" - 2016

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Honeybaked hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY
