

"Katie's Hollywood Getaway Sweepstakes"

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Disney ABC Domestic Television (DADT), hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY

Open only to legal residents of California, 18 years of age or older and must be in the ABC7 KGO-TV viewing area as defined by the A.C. Nielson Company (Alameda, Contra Costa, Lake, Marin, Mendocino, Napa, San Francisco, San Mateo, Santa Clara, Solano & Sonoma counties).

First Prize: One (1) First Prize winner will get Katie Show gift bag merchandise.

Entry in this Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes.

Drawing will be conducted by Administrator. By participating, entrants agree to the Official Rules and the decisions of the Administrator, which shall be final and binding in all respects.

Winner will be notified by phone and/or e-mail.

Grand Prize Winner will be determined by random drawing that will be held on or about April 15, 2013. Conduct of the Sweepstakes and the drawing are under the

supervision of the Administrator. Odds of winning depend on number of valid entries received. Final determination of winner is always conditional on verification of eligibility and compliance with all rules and procedures. Potential winner will be notified by using the contact information provided at the time of entry. Sponsor and Administrator shall have no liability for any potential prize winning notification that is lost, intercepted or not received by any potential winner for any reason. If a potential winner cannot be reached within two (2) days of notification of winning or if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, winner will be disqualified and an alternate winner may be selected. Prize not claimed within 3 days will be forfeited.
