

# **“Ringling Bros. Barnum & Bailey – Circus Extreme” 2015 Sweepstakes**

## **Official Rules**

### **I. NAME OF SPONSOR & ADMINISTRATOR**

Feld Entertainment, hereafter referred to as “Sponsor.”

ABC7 KGO-TV, hereafter referred to as “Administrator.”
