

"Rod Stewart Sweepstakes Promotion"
Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

ENTERTAINMENT MARKETING GROUP, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY
