

"SOLO: A STAR WARS STORY SWEEPSTAKES" - 2018

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Disney Studios, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY
