

"Wallbeds "n" More" Sweepstakes

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Wallbeds "n" More, hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY
