My name is Jude Thomsen, Lynn Thornton's sister in law. I feel the need to write to you about the above-referenced case with charges toward Mr. Bismark Dinius. This incident, which happened in Lake County, was a tragic loss to our family. The death of our sister Lynn Thornton changed our lives forever.

A family should never have this kind of pain and suffering. What has felt even more painful is the criminally charged man Bismark Dinius had nothing at all to do with this. He is wrongly accused of this tragic loss, and the one and only person who is responsible is Russell Perdock. How is justice being served with this man not being held responsible for his actions ending in the death of my sister in-law?

Of course we have followed the entire story as information has un-folded starting April 29, 2006.
