

**"Universal Studios Hollywood – Ultimate Hollywood Movie Experience
Sweepstakes" 2017**

Official Rules

I. NAME OF SPONSOR & ADMINISTRATOR

Universal Studios Hollywood hereafter referred to as "Sponsor."

ABC7 KGO-TV, hereafter referred to as "Administrator."

II. ELIGIBILITY

Open only to legal residents of California, 18 years of age or older and must be in the ABC7 KGO-TV viewing area as defined by the A.C. Nielson Company (Alameda, Contra Costa, Lake, Marin, Mendocino, Napa, San Francisco, San Mateo, Santa Clara, Solano & Sonoma counties).

There will be one (1) Prize ("Prize") awarded. Prize winner ("Winner") will receive a three (3) day, two (2) night trip for Winner and up to three (3) Guests ("Guests") to Universal Studios Hollywood. Trip will include round trip coach class air transportation for Winner and up to three (3) Guests from a major commercial airport near Winner's home (as determined by Prize Provider in their sole discretion) to Los Angeles, CA*; two (2) nights standard hotel accommodation (one room, quadruple occupancy, room and tax only) at Universal Sheraton (or at another on-site hotel as determined by the Prize Provider in their sole discretion); non-exclusive ground transportation to and from airport and hotel in Los Angeles, CA*; One (1) day General Admission tickets to Universal Studios Hollywood for Winner and up to three (3) Guests.
