

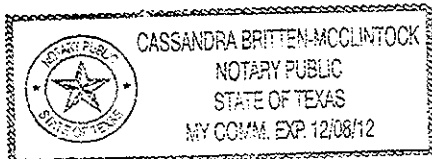
The test was conducted by a certified breath test operator who is trained in the required methodology for breath testing namely **R B PEREZ**, Certificate No. **22384**.
