**IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:**

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, JUSTIN WAYNE PARRIS hereafter styled the Defendant, heretofore on or about NOVEMBER 6, 2009, did then and there unlawfully intentionally and knowingly cause the death of JOHNNIE GONZALES-MORALES, hereinafter called the Complainant, by STABBING THE COMPLAINANT WITH A KNIFE.

It is further presented that in Harris County, Texas, JUSTIN WAYNE PARRIS, hereinafter styled the Defendant, heretofore on or about NOVEMBER 6, 2009, did then and there unlawfully intend to cause serious bodily injury to JOHNNIE GONZALES-MORALES, hereinafter called the Complainant, and did cause the death of the Complainant by intentionally and knowingly committing an act clearly dangerous to human life, namely BY STABBING THE COMPLAINANT WITH A KNIFE.

**PROBABLE CAUSE**

Your Affiant, O. Chandler, a peace officer employed by the Houston Police Department, believes and has reason to believe that the defendant, JUSTIN WAYNE PARRIS, committed the offense of MURDER on or about November 6, 2009 in Harris County, Texas. Your Affiant bases this belief upon the following facts:

On November 6, 2009, your Affiant was assigned to conduct a follow up investigation regarding the death of JOHNNIE MORALES-GONZALES. Your Affiant arrived at 902 Lamonte in Harris County, Texas at approximately 6:25 p.m. Your Affiant observed an obviously deceased white male lying on the floor of the living room at the location, with a blanket covering his body. Your Affiant observed that the deceased male's head had been completely severed from the body and was sitting next to the body. Your Affiant then spoke to Danielle Rene Reyna who stated that she knows the deceased male by name and by sight because he is her grandfather. Danielle stated that she is twelve years old and that she lives at the location with the Complainant and the defendant, who is her brother. She stated that their mother, who is the Complainant's daughter, has been in the hospital for approximately 3 weeks. Danielle stated that the morning of November 6, her grandfather took her to the bus stop to go to school. She stated that it was her grandfather's usual practice to take her to the bus stop and to pick her up from the bus stop after school. She stated that when she went to school, the defendant was at home. She stated that when she got off of the bus on this day, she noticed that he was not at the bus stop. She stated she went into a nearby store and called home. She stated that the defendant answered the phone. Danielle stated that she asked the defendant where was their grandfather? She stated that the defendant told her that the grandfather wasn't there (at home.) Danielle stated that she then walked home, arriving at home at approximately 4:00 p.m. She stated that she noticed the defendant outside on the porch, pacing back and forth. She stated that she asked the defendant if their grandfather was home and he told her, "No." Danielle stated that she walked into their home and noticed that their grandfather's vehicle was parked in the back, so she started towards the back of the house. She stated that she then noticed what appeared to be a body lying on the floor of the residence, covered with a blanket. Danielle stated that she saw a hand and wrist protruding from under the blanket and she knew it was her grandfather. Danielle stated that she yelled at the defendant, "What did you do to Grandpa?" She stated the defendant told her, "Nothing." Danielle stated that she started crying and called 911 and was told by the 911 operator to hand the phone to the defendant. She stated that when she did, he hung up the phone.

When your Affiant arrived on the scene, she noticed the defendant had what appeared to be blood spatter on the front of his shirt, and blood smears on the front of his pants. Your Affiant also noticed that the defendant had a bandaged right "pinkie" finger and a large laceration to the top of his right forearm. Your Affiant then spoke to the defendant in a voluntary interview. The defendant told your Affiant that he had been home all day and that nobody had come over to the house. When your Affiant asked the defendant any questions concerning the Complainant,

the defendant stated that "he didn't remember" and that "he didn't want to talk about it." He initially told your Affiant that he didn't see the Complainant all day, but when your Affiant asked him about who placed the blanket over the Complainant's body, the defendant admitted that he had done so. When your Affiant asked him why did he put the blanket over the Complainant, the defendant stated, "Because he was dead and I didn't want to see him like that anymore." Your Affiant then asked him, "How did he know he was dead?" The defendant refused to answer. Your Affiant asked the defendant, "Was he sick?" The defendant answered, "No." When your Affiant asked the defendant why he didn't call 911, he stated that he didn't remember. Your Affiant then asked the defendant, "Is it that you don't remember or because you don't want to talk about it?" The defendant replied, "I don't want to talk about it."

At the scene, your Affiant's partner, J. Johnson, observed a pair of hedge clippers just inside of the garage. Officer Johnson noticed what appeared to be blood on the blade of the clippers, as well as the handle. Your Affiant also observed drops of blood leading from the body location to the bathroom. In the bathroom, your Affiant observed bloody towels and smears which appeared to be from someone who was bleeding and attempting to clean up.

Your Affiant spoke to Innocencia Gonzales, who stated that she is the Complainant's ex-wife. She stated that she lives next door to the Complainant at 906 Lamonte. She stated that the Complainant has told her on several occasions that he was afraid of the defendant. She also stated that she observed injuries on or about the Complainant's body that the Complainant stated was due to the defendant's actions. Your Affiant also spoke to other relatives who stated the same thing.


