IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **MICHAEL GLYN BROWN** hereafter styled the Defendant, heretofore on or about **AUGUST 13, 2010**, did then and there unlawfully intentionally and knowingly cause bodily injury to **RACHEL BROWN**, hereafter styled the Complainant, a member of the Defendant's family, by **TWISTING THE COMPLAINANT'S ARM BEHIND HER BACK**.

It is further presented that before the commission alleged above, the Defendant, on **JANUARY 30, 2002**, in the **221ST DISTRICT COURT** of **MONTGOMERY County, Texas**, in Cause No. **01-04-02621-CR**, was convicted of **AGGRAVATED ASSAULT** which was committed against a member of the Defendant's family.

PROBABLE CAUSE

Affiant, **M. L. Holbrook**, is employed as a peace officer with the **Houston Police Department**. Affiant believes and has reason to believe that **Michael Glyn Brown**, hereinafter referred to as the defendant, committed the felony offense of assault against a family member second offender on or about **August 13, 2010**, in **Harris County, Texas**.

Affiant spoke to **Rachel Brown**, who told affiant that she knows the defendant by name and sight because he is her husband and they have two children together. She told affiant that they argued on **August 13, 2010** at their home in **Houston, Harris County, Texas**. She told affiant that he grabbed her arm and bent it behind her back and twisted it as if he meant to break her arm. The complainant screamed and felt pain as a result of the assault.

Affiant also has learned that the defendant, **Michael Glyn Brown**, received deferred adjudication out of **Montgomery County, Texas** for aggravated assault against a family member on **January 30, 2002** in Cause number **01-04-02621-CR** for an offense that occurred on **January 24, 2001** against **Darlina Brown**, a member of the defendant's family.

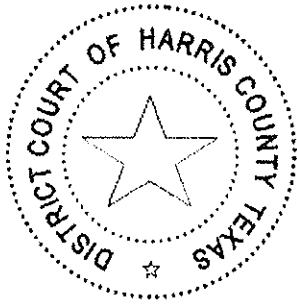
