PROBABLE CAUSE:

Affiant Rebecca Sosa is a peace officer employed by the Memorial Villages Police Department. Affiant has reason to believe and does believe that Edward Knoblauch, hereafter the Defendant, committed the offense of Assault of a Family Member; Choking in Harris County, Texas, on or about September 25, 2009.

Affiant's beliefs are based on the following:

Affiant spoke to Stacey Stelmach, hereafter the Complainant. The Complainant stated, on September 25, 2009 she was at [redacted] in Harris County, Texas. According to the Complainant, on September 25, 2009 her husband, whom she knows by name and sight to be Edward Knoblauch, hereafter, the Defendant, struck her with his hand on her face and then choked her with his hand by applying pressure to her neck with his hand. The Complainant stated this caused her pain. Affiant observed the Complainant to have redness around her neck and swelling near her eye consistent with her statement.
