Narrative

Details:

On 11-14-07, around 2pm, I heard the police radio broadcast a reported burglary in progress at 7400 Timberline. I was in the area of Farimont and Beltway #8, working as a plain clothes narcotics detective.

I was aware of the fact it was close to shift change for patrol and that I might be able to respond quickly to the scene. The police dispatcher was giving updated information over the police radio while I was enroute to the Timberline address. The updated information included a description of two,black males were in the back yard and then had forced their way inside home.

A neighbor / reportee was telling dispatch that he was going to confront the suspects, while armed with a weapon. I turned eastbound on Timberline and was looking for the address. I was driving an unmarked police vehicle and in plain clothes. I was wearing a police raid vest at this time. I was diving slowly E/B and knew by the house numbers that I was getting close to the right address.

I stopped almost directly in front of 7418 Timberline in the middle of the roadway. I looked right and saw two ,black males that matched the dispatchers description coming out of the fenced back yard of 7422 Timberline. This was just a little east of where I had stopped. The two black males had walked out of a wooden gate between 7418 and 7422 Timberline. These two houses were located on the South side of the roadway and face North. The below events took place within a matter of seconds.

One of the black males was wearing a white ball cap and had longer hair than the other.

Narrative

They were both dressed in similar clothing of jeans and a work type shirt. The male with the longer hair was also carrying a plastic bag by clutching his arm around the bag and holding it to his chest. I was attempting to use the police radio to tell dispatch that I was checking out on the suspects. At the same instant the dispatcher was broadcasting more information and I had to wait for him to finish. My intention at that point was to exit my vehicle, as soon as I checked out on the radio and confront the suspects.

The two black males were walking almost shoulder to shoulder and made a westerly turn into the front yard of 7418 Timberline. About the same time that they had walked a few steps into the yard of 7418 Timberline, I saw an older white male emerge from the front porch area of that home. I had not seen this older, white-haired, male before he stepped out from the porch area. The first time I saw the white male he had a shotgun shouldered and was about to confront the two black males. He pointed the shotgun in the direction of the two males and he called out some sort of verbal command. I assumed his vocalization was directed at the black males.

Almost at the same instant the two black males separated and ran in different directions. The black male wearing the white ball cap turned and ran E/B and the other black male ran W/B. I saw the older, white male discharge the shotgun once in the direction of the black male running W/B and then once in the direction of the black male running E/B. He then walked back inside the house he had came out of.

At this point, I stayed inside my truck advising the police dispatcher that shots were being fired. I did not want the male shooting to think I was with the males involved in the burglary. I watched the black male that ran N/W across the roadway fall in the grass in the front yard of a home across the street. I saw the black male with the white ball cap and bag dip his left shoulder after the shotgun was discharged in his direction. He dropped the bag he was carrying and the white ball cap fell off close by. He continued to run east and I followed in my truck. At point I did not know he had been shot and was thinking I was going to be involved in a foot pursuit with this suspect.

The black male with the longer hair ran a short distance and made a S/B turn into the grass alley between two homes. He stumbled a few steps and then fell down on his chest. I exited my truck and ran directly to this suspect. I saw that he was bleeding profusely from his mouth and nose area. I also saw that he appeared to exhale his breath and I checked for a pulse and could not find one.

I called for an ambulance and "Life flight" to be placed on standby. I told dispatch that the two suspects were down and apparently had been shot. Responding unit arrived in a very short time and I directed other units to check on the other suspect on the North side of the road. I also told them where the person doing the shooting had gone.

I never made any contact with the person I had seen do the shooting in the direction of the two suspects.

I remained on scene until I was released by the Detectives investigating the shooting. See there supplement to the original report.
