FIRST COUNT

THE GRAND JURY OF THE COUNTY OF THE BRONX BY THIS INDICTMENT,  
ACCUSES THE DEFENDANT RICHARD HASTE OF THE CRIME OF MANSLAUGHTER IN THE  
FIRST DEGREE COMMITTED AS FOLLOWS:

THE DEFENDANT, RICHARD HASTE, ON OR ABOUT FEBRUARY 2, 2012, IN THE  
COUNTY OF THE BRONX, DID CAUSE THE DEATH OF RAMARLEY GRAHAM, WHILE ACTING  
WITH INTENT TO CAUSE SERIOUS PHYSICAL INJURY TO THAT PERSON, BY SHOOTING  
HIM.

SECOND COUNT

THE GRAND JURY OF THE COUNTY OF THE BRONX BY THIS INDICTMENT,  
ACCUSES THE DEFENDANT RICHARD HASTE OF THE CRIME OF MANSLAUGHTER IN THE  
SECOND DEGREE COMMITTED AS FOLLOWS:

THE DEFENDANT, RICHARD HASTE, ON OR ABOUT FEBRUARY 2, 2012, IN THE
