I WOULD LIKE TO TELL YOU WHAT HE SAID. BUT I WOULD RATHER TELL YOU IN PERSON ABOUT YOU AND YOUR WIFE. YOU WILL NOT BE HAPPY, WHEN THE TIME COMES, WHEN I TELL YOU WHAT HE SAID. WE ARE GOING TO START THE QUESTIONS AND ANSWERS. IF YOU DO NOT REMEMBER SOME OF THEM, PLEASE SAY, I DO NOT REMEMBER.

DO YOU REMEMBER WHEN YOU WOULD COME BY THE HOUSE, WITH MY SON, AND YOUR WIFE, EVER SEE ME MISTREATING MY BOYS OR THEIR WIVES? AT ANY TIME DID YOU SEE ME DO THAT?

YOU HAVE BEEN IN MY COMPANY MANY TIMES. NOT ONLY HERE IN THE CHICAGO AREA, BUT IN FLORIDA, WHY WERE IN EACH OTHERS COMPANY, DID YOU EVER HEAR ME SAY ANYTHING BAD ABOUT MY BOYS?

I WANT YOU TO REFRESH YOUR MIND. WHEN YOU USED TO COME TO MILAN TO VISIT YOUR BUDDY FRANK JR. HOW YOU AND I AND THE REST OF THE GUYS THAT WERE VISITING JR HAD SOME NICE TIMES. WE ALSO TOOK PICTURES THAT I STILL HAVE TO THIS DAY. NOT ONLY AT MILAND BUT ALSO WHEN WE WERE IN FLORIDA.

“QUESTION.” YOU REMEMBER HOW JR WAS SO HUMBLE, AND KIND TO ME WHEN WE WERE AT MILAND? DID YOU NOT SEE HIM HUG AND KISS ME, AND TELL ME THAT HE LOVED ME?

“QUESTION.” TELL ME EVERYTHING YOU CAN IN REGARDS TO FRANKIE TELLING YOU HOW HE WANTED TO SET ME UP. ANYTHING YOU SAY WILL STAY AMONG US. AS YOU KNOW I AM NOT A PERSON TO TELL OTHER PEOPLE WHAT I AM DOING WITH ANY OTHER PEOPLE.

DID HE NOT TELL YOU, JR. EVEN THOUGH MY FATHER HAD NOTHING TO DO WITH ANY OF THOSE MURDERS, AND HE TOLD YOU

THAT HE TOLD HIS FATHER "AWE DAD COME ON THAT IS NOT TRUE IS IT?" HE ALSO TOLD YOU THAT HIS FATHER TOLD HIM THAT IT IS TRUE, THAT I HAD NOTHING TO DO WITH ANY OF THOSE MURDERS.

THE ANTIQUE CAR IN HUNTLY, ABOUT A YEAR AFTER JR LEFT PRISON. ABOUT TWO YEARS AGO THERE TWO 1937 FORDS. THEY WERE TAKEN FROM A GARAGE IN ELMWOOD PARK, IL. DID HE MENTION ANYTHING

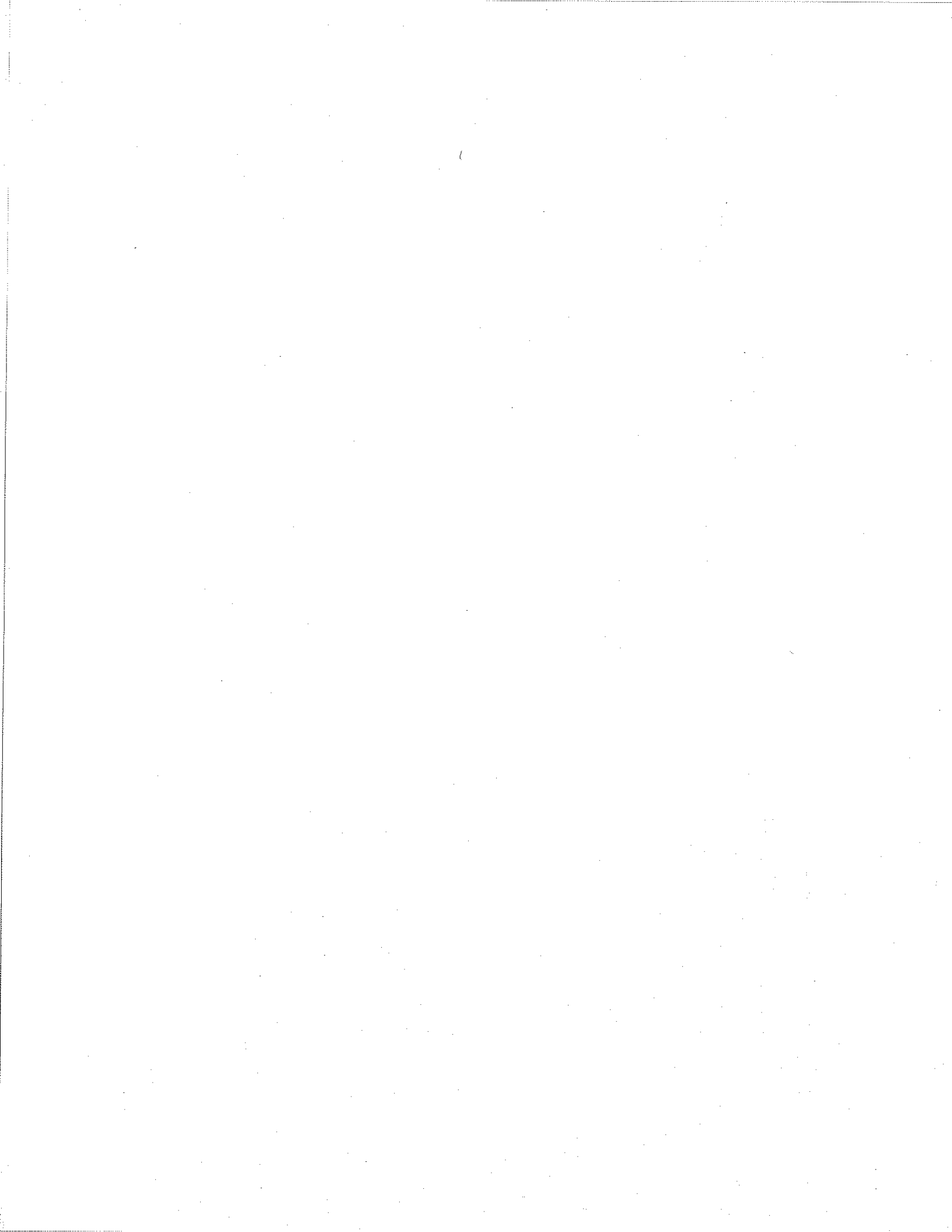

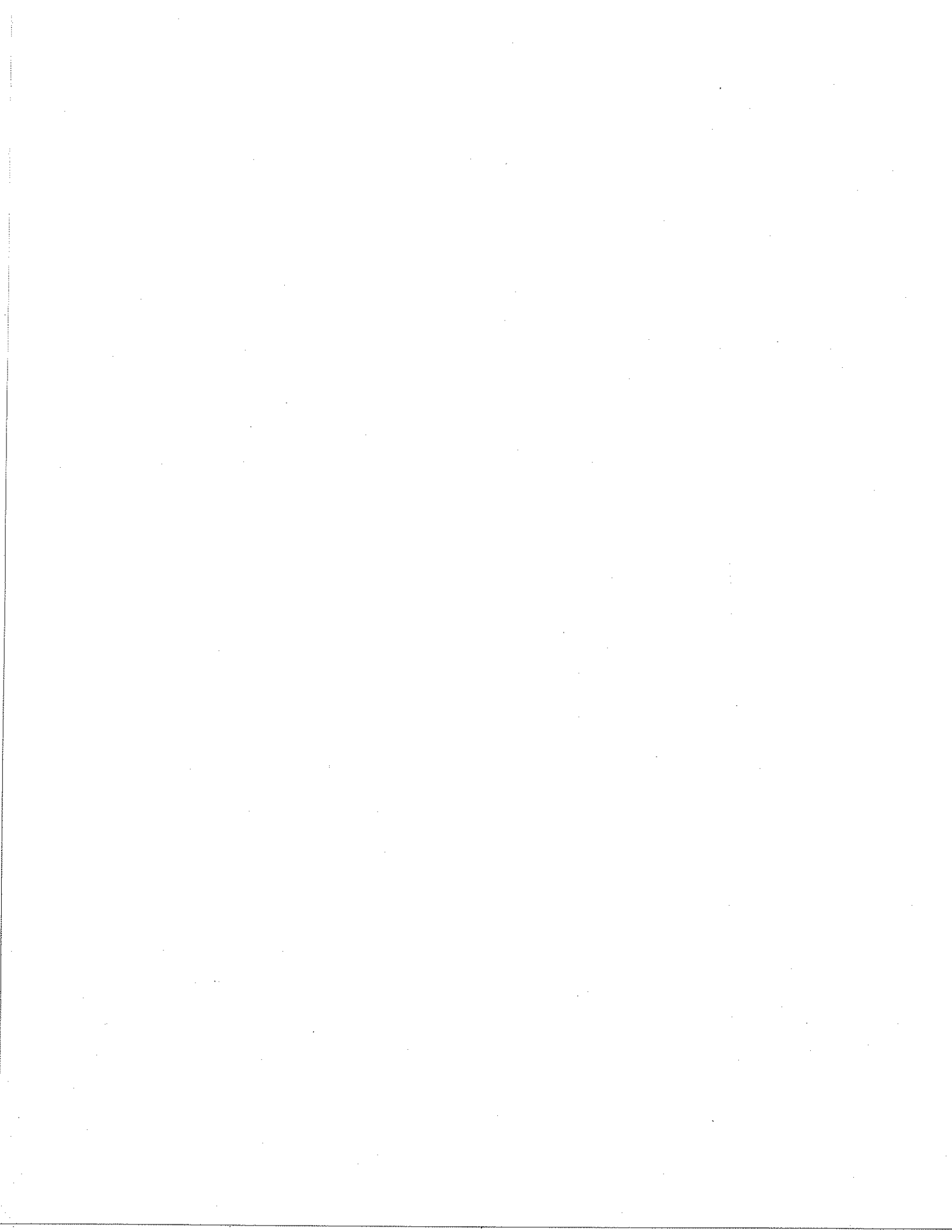
