EVENT #06289 IN SUMMARY R/O'S SET UP SURVEILLANCE IN A KNOWN NARCOTICS LOCATION. R/O'S OBSERVED 3 MALE BLACKS STANDING IN FRONT OF SAID LOCATION ALONG WITH A 4TH SUBJECT IN THE GANGWAY. THE UNKNOWN SUBJECT WAS THEN OBSERVED WALKING TOWARDS THE REAR OF THE LOCATION AND LIFTING THE BOTTOM STAIR OF THE REAR PORCH AND PLACING UNKNOWN ITEM INTO IT. SUBJECT THEN CLOSED THE STAIR AND WALKED TOWARD THE FRONT OF THE LOCATION AT WHICH TIME R/O'S LOST VISUAL CONTACT OF SUBJECT. A SECOND SUBJECT WAS OBSERVED GOING TO THE PASSENGER SIDE OF A VEHICLE PARKED IN A DRIVEWAY ACROSS THE STREET AND PLACING UNKNOWN ITEM IN THE CENTER CONSOLE. R/O'S THEN BROKE SURVEILLANCE AND APPROACHED SUBJECTS FOR A FIELD INTERVIEW. R/O'S THEN WENT TO SAID REAR STAIR AND RECOVERED FROM INSIDE IT ONE PLASTIC BAG CONTAINING; (7) KNOTTED BAGGIES AND (5) SMALL ZIP-LOC BAGGIES ALL CONTAINING CRUSHED GREEN LEAFY SUBSTANCE SUSPECT CANNABIS INV #13578767. R/O'S COULD NOT LOCATE THE SUBJECT GOING TO THE REAR STAIR AND COULD NOT IDENTIFY HIM AT THIS TIME. [REDACTED]

R/O'S THEN CONDUCTED A SEARCH OF VEHICLE WITH NEGATIVE RESULTS, BUT DID OBSERVE A LARGE BUNDLE OF US CURRENCY IN CENTER CONSOLE WHICH WAS LEFT IN VEHICLE. █████ A SUBJECT ON SCENE WAS CONTACT CARDED AND RELEASED ON SCENE.
