

WRIT OF EXECUTION

TO THE UNITED STATES MARSHAL, HIS DEPUTIES AND AGENTS:

The United States District Court for the Northern District of Illinois sentenced the defendant, Frank J. Calabrese, Sr. on January 28, 2009, and ordered him to pay restitution in the amount of \$4,422,572.89 on April 6, 2009. The Court entered the Amended Judgment on September 3, 2009. Defendant Frank J. Calabrese, Sr.'s current address is MCFP Springfield, 1900 W. Sunshine Street, Springfield, Missouri 65807, and his last known residential address is 14 Meadowood Drive, Oakbrook, Illinois 60523. As of March 15, 2010, the outstanding judgment balance owed is \$4,378,347.16. Interest was waived pursuant to 18 U.S.C. § 3612(f).

NOW, THEREFORE, YOU ARE HEREBY COMMANDED to satisfy the judgment by levying on and selling property in which the defendant has a substantial nonexempt interest (not to exceed property reasonably equivalent in value to the aggregate amount of the judgment and costs), by executing upon property of the defendant-judgment debtor described below:

The execution sale shall be conducted in a commercially reasonable manner pursuant to 28 U.S.C. § 3203(g) of the Federal Debt Collection Procedures Act.

In performing the levy, you shall enter the real property and post the writ and notice of levy in a conspicuous place upon the property.

In performing the levy, you are authorized to use reasonable force to enter any property owned, occupied, or controlled by the defendant-debtor and enter any residences, buildings, garages, or structures situated upon the real property.

In performing the levy, you shall take possession of the personal property. You are further authorized to use reasonable force to search for the judgment debtor's personal property and investigate any locations within the subject premises, including safes, compartments or any partitioned section or storage area that may reasonably contain any items of value. You shall take inventory of all personal property not taken from each premises by photograph or video. 28 U.S.C. § 3013.

You shall file a copy of the notice of levy in the same manner as provided for judgments in 28 U.S.C. § 3201.

You shall also serve a copy of the writ and notice levy on the judgment debtor and the person(s) having possession of the property subject to the writ in the same manner that a summons is served in a civil action and make the return thereof. 28 U.S.C. § 3102(d)(5).

You shall endorse, in the space provided below, the exact hour and date of receipt of this writ of execution. You shall make a written record of every levy, specify the property on which levy is made, the date on which levy is made, and the United States Marshal's costs, expenses, and fees.

YOU ARE FURTHER COMMANDED to make a written return to the Court on each writ of execution stating concisely what is done pursuant to the writ and shall deliver a copy to the United States Attorney, Northern District of Illinois.

YOU ARE ALSO COMMANDED to make return of this writ within ninety days after the date of issuance if levy is not made, or within ten days after the date of sale of property on which levy is made.

YOU ARE FURTHER COMMANDED to have an appraisal of the real property performed to ensure that the levy and sale do not exceed property reasonably equivalent in value to the aggregate amount of the judgment and costs. In connection with this appraisal, you and any appraisal service you retain are authorized to enter the property in order to conduct such appraisal.


