## PETITION FOR CONDITIONAL USE PERMIT

The petitioner, FRATERNITE OF NOTRE DAME, INC., Owner of Record, by and through its attorney, ZANCK, COEN, WRIGHT & SALADIN, P.C., respectfully represent to the Zoning Board of Appeals of McHenry County, as follows:

- 1. The petitioner, FRATERNITE OF NOTRE DAME, INC., of 10002 Harmony Hill Road, Marengo, IL 60152, is the owner of Parcel 1 and of Parcel 2 of the real estate described on Exhibit A, attached hereto and incorporated herein by reference hereinafter collectively referred to as "Premises".
- 2. The Premises consists of approximately 95 acres and is commonly known as 10002 Harmony Hill Road, Marengo, IL 60152, and is located on the East side of Harmony Hill Road, one-half mile North of its intersection with Church Road, Parcel 1 of Premises has a single-family residence, two garages, a church, bakery and barn and Parcel 2 of Premises has a single-family residence on it.
  - 3. The Petitioner requests that its Conditional Use Permit #05-04 be amended as follows:
    - A. To add 30 acres to the Conditional Use Permit as Parcel 2; set forth on Exhibit

Α.

B. To allow it to build a barn on Premises to be able to:

i. build a commercial kitchen;



- ii. process grapes for wine making purposes therein;
- iii. brew beer;

## C. To allow it to build and operate:

- i. a school with an attached dormitory;
- i. a nursing home which would include hospice services; and
- iii. a gift shop to sell pastries, religious and inspirational articles and wine made on the premises with a pastry, beer and wine tasting area;
- 4. The Premises, which is the subject of this petition, consists of approximately 95.00 acres and is located in Coral Township, McHenry County, Illinois.
- 5. Parcel 1 of Premises is presently classified A-1 Agricultural District with a Conditional Use permitting the construction of a place of worship, including a monastery, a church, seminary, convent, retreat center, bakery, printing press and a cemetery subject to conditions. Parcel 2 of Premises is zoned A-1.
- 6. The Petitioner, FRATERNITE OF NOTRE DAME, INC., is a religious order and plans to use the existing structures and add several new buildings as requested in this Petition to further its charitable works.
- 7. All contiguous property is classified under the McHenry County Zoning Ordinance is follows: East A-1; South A-1; West A-1; and North A-1.
  - 8. The surrounding properties are used as agriculture and single family homes.
- 9. Petitioners shall meet the standards for conditional uses as outlined in Section 5.4.E.

  The site is situated so that it is compatible with existing planned and future development of the area. The establishment, maintenance or operation of this conditional use is not detrimental to or endangering the public health, safety, morals, comfort or general welfare of the neighboring property. The conditional use is not injurious to the use of the adjoining property and the meaningful and significant purposes already permitted. The conditional use will not substantially diminish or impair the property values within the neighborhood. There are

adequate utilities, access roads, drainage and other necessary facilities have been provided, and adequate measures have been taken to provide an increase in the egress in order to minimize traffic congestion. The conditional use conforms in all the respects with the applicable regulations of the McHenry County Unified Development Ordinance for the district in which it is located. The conditional use is reasonably in the interest of the public welfare.

10. The list of the surrounding property owners are to be given proper notice of the hearing, is attached as Exhibit B.

WHEREFORE, your Petitioner, FRATERNITE OF NOTRE DAME, INC. request the Chairman of the Zoning Board of Appeals of the County of McHenry, State of Illinois, set a date, time and Place for a public hearing to be held for the purposes of amending its existing Conditional Use Permit.


