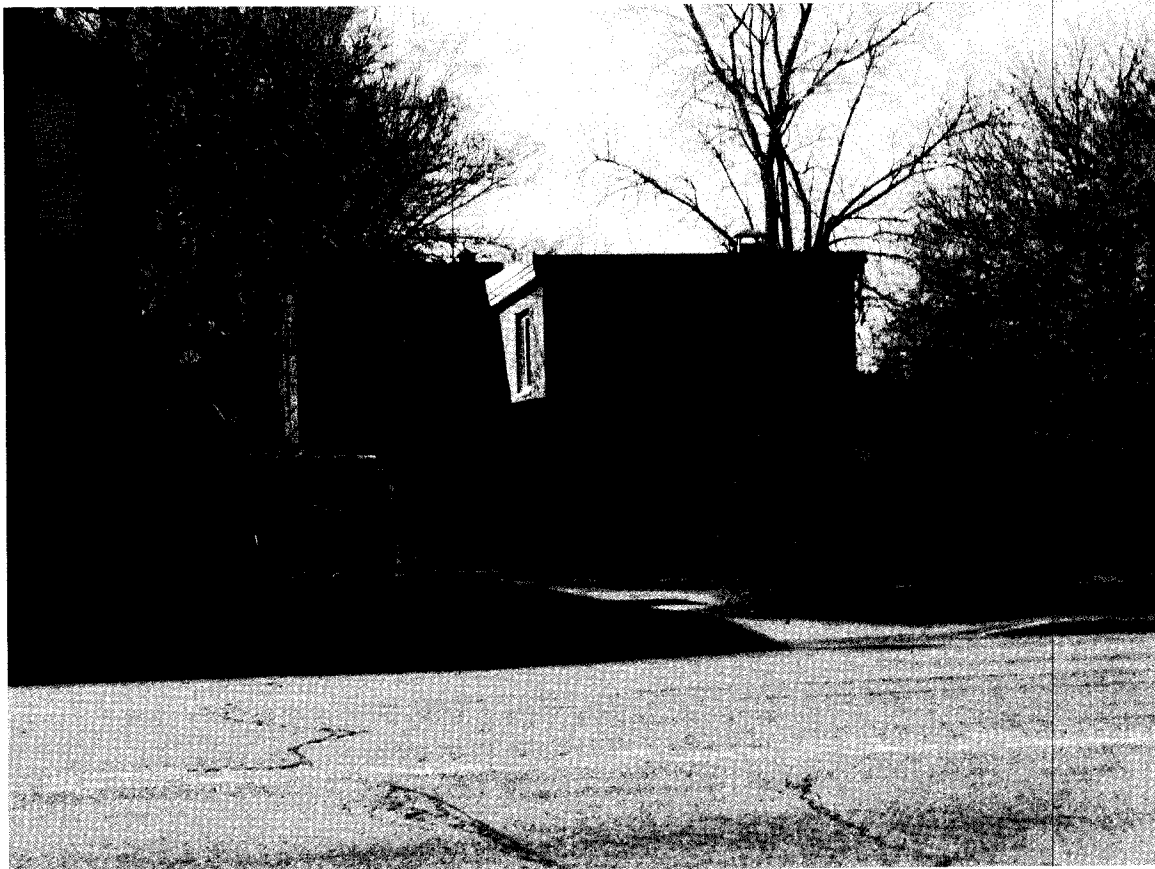

Agents may search for and seize:

1. Computer hardware (including laptop and desktop computers); and
2. Any and all records, documents and materials pertaining to Title 18, United States Code Subsection 2384, 2332(a), 842(p)(2)(A), 842(a)(1), 924(c)(1)(A), and/or Title 26, Subsection 5861 (d) , including, but not limited to any such records, documents and materials pertaining to:
 - a) Diaries, appointment books, calendars, address or telephone lists, HUTAREE related correspondence or papers that reflect the names, addresses, pseudonyms, pager number(s), email address(es) and/or telephone numbers for their members, associates in the organization, even if said items are in code;
 - b) Any and all records, documents and materials pertaining to the ownership and/or possession of the searched premises including the purchase and/or title to their real or personal assets;
 - c) Any and all records and documents relating to any communications including email communications between members of the Hutaree and others;
 - d) Any and all records, documents and materials, photographs, audio and/or video tapes (including electronic storage devices such as external hard drives or thumb drives) of themselves, their associates, their weapons and training activities;
 - e) Any and all radios, cellular phones, and communication devices;
 - f) Any and all firearms - including firearms parts and components to include but not limited to: magazines, silencers, receivers, scopes, and firearm paraphernalia;
 - g) Documentation regarding the ownership or purchase of firearms, explosive materials, components and other such materials;
 - h) Explosive materials - including but not limited to: black powder, pyrodex, smokeless powder, flash powder, and any other material as listed in the Federal Register as explosive materials;
 - i) Destructive devices;
 - j) Ammunition, ammunition components;

- k) Tools and material for the manufacture or modification of firearms, destructive devices and/or explosives, items used to construct explosive and/or destructive devices which includes but is not limited to PVC/metal pipe, cardboard tubes, fuses (eg. "hobby fuse", "cannon fuse", "safety fuse", wicks), shotgun shells, end caps, electrical tape, wire, cans, wine bottles, street signs, metal disks, batteries, flash light bulbs, and electric matches;
- l) Cameras, video cameras, electronic storage devices such as external hard drives or thumb drives, manuals and documents related to the manufacture of illegal firearms or explosives and destructive devices;
- m) Indicia of HUTAREE membership including but not limited to uniforms, patches, flags, military supplies marked with HUTAREE names or identifiers;
- n) Military gear, knives, membership lists, radios and cell phones, gps units, body armor, "ghille" suits, night vision goggles, face paints, face clothes, balaclavas;
- o) "Booby-trap" components, which includes but not limited to wires, batteries, "popsicle" sticks, clothes pins, command detonation control panels, vice grips, pliers, push pins, thumb tacks;
- p) Any items or documents used in the planning and gathering of intelligence from law enforcement agencies for use in the planning of attacks on those agencies;
- q) Militia based literature, "hit lists," diagrams, maps, drawing and action plans.

Definitions

As used above, the term "Computer Hardware" consists of all equipment that can collect, analyze, create, display, convert, store, conceal, or transmit electronic, magnetic, optical, or similar computer impulses or data. This includes any data-processing devices (such as central processing units, memory typewriters, and self contained "laptop" or "notebook" computers); internal and peripheral storage devices (such as fixed disks, external hard disks, floppy disk drives and diskettes, tape drives and tapes, optical storage devices, transistor-like binary devices, and other memory storage devices.)

As used above, the terms "records, documents, and materials" includes records, documents, materials, programs, or applications created, modified or stored in any form, including electronic or digital form, and by whatever means they may have been created and/or stored. This includes any handmade, photographic, mechanical, electrical, electronic, and/or magnetic forms. It also includes items in the form of computer hardware, software, documentation, passwords, and/or data security devices.
