PRIMARY NARRATIVE

IN SUMMARY, ON THE DATE AND TIME LISTED R/O WAS DISPATCHED TO THE LISTED LOCATION IN REFERENCE TO A POSSIBLE ATTEMPT SUICIDE WHICH POSSIBLY OCCURRED IN OUR TOWN. UPON R/O'S ARRIVAL TO THE OAK FOREST HOSPITAL, R/O SPOKE WITH THE PUBLIC SAFETY WATCH COMMANDER LT. RAMON HONORE.
