SUPPLEMENTAL NARRATIVE

ON LISTED DATE AND TIME R/LT, DETECTIVE MCKINNEY AND CHIEF EVANS PROCEEDED TO THE OFFICE OF TERRY GILLESPIE, ATTORNEY FOR CLARISSA FLORES-BUHELOS (53 W. JACKSON, SUITE #1420, CHICAGO, ILLINOIS). ON ARRIVAL, R/LT, DETECTIVE MCKINNEY AND CHIEF EVANS RELOCATED TO SUITE #1420, AT WHICH TIME ATTORNEY GILLESPIE SPOKE WITH OFFICERS REGARDING INTERVIEW OF HIS CLIENT, ATTORNEY GILLESPIE RELATED THAT HIS CLIENT WAS WILLING TO SPEAK ABOUT THE INCIDENT AND HE RELATED THAT SHE WOULD PROVIDE INFORMATION THAT WOULD ASSIST IN THE INVESTIGATION. AT THAT TIME ATTORNEY GILLESPIE RELOCATED FLORES-BUHELOS TO HIS OFFICE WHERE THE INTERVIEW WAS CONDUCTED. AT THAT TIME FLORES-BUHELOS PROVIDED THE FOLLOWING INFORMATION IN SUMMARY AND NOT VERBATIM: ON TUESDAY MORNING, 09/08/09, FLORES-BUHELOS ADVISED THAT LISTED VICTIM, CHRISTOPHER KELLY, RECEIVED A TELEPHONE CALL FROM HIS ATTORNEY, MICHAEL MONICO, FLORES-BUHELOS ADVISED THAT KELLY'S ATTORNEY ADVISED HIM THAT HE NEEDED TO GO TO COURT REFERENCE A POSSIBLE REVOCATION OF HIS BAIL DUE TO AN INCIDENT AT THE CLUB WHERE FLORES-BUHELOS IS EMPLOYED. FLORES-BUHELOS RELATED THAT AFTER GOING TO COURT VICTIM PROCEEDED TO THEIR RESIDENCE AT ILLINOIS, FLORES-BUHELOS FURTHER STATED THAT VICTIM APPEARED TO BE QUIET AND HAD AN UNUSUAL DEMEANOR. FLORES-BUHELOS RELATED THAT VICTIM THEN DEPARTED FOR COURT ON A SECOND OCCASION BECAUSE HE WAS DUE BACK AT APPROXIMATELY 1300 HOURS. FLORES-BUHELOS ALSO ADVISED THAT VICTIM ALSO STATED THAT HE WAS GOING TO SEE HIS DAUGHTERS. FLORES-BUHELOS RELATED THAT AT APPROXIMATELY 1930 HOURS SHE RECEIVED A CALL FROM VICTIM ON HER CELLULAR PHONE AT WHICH TIME VICTIM RELATED THAT HE HAD FALLEN ASLEEP AT THE "YARD" AND HE STATED THAT HE HAD TAKEN SOME PILLS. FLORES-BUHELOS ADVISED THAT SHE TOLD VICTIM THAT SHE WOULD PROCEED TO THE "YARD", WHICH FLORES-BUHELOS CONFIRMED WAS THE STORAGE YARD NEAR FOREST LUMBER/TRUE VALUE AT 17280 S. CICERO AVENUE. FLORES-BUHELOS ADVISED THAT SHE PROCEEDED TO THE YARD AND ON ARRIVAL FOUND THE GATE TO THE YARD TO BE LOCKED. FLORES-BUHELOS ADVISED THAT SHE JUMPED THE FENCE TO THE YARD AND AT THAT TIME OBSERVED VICTIM WALKING IN THE YARD WITH A FLASHLIGHT, FLORES-BUHELOS RELATED THAT VICTIM WAS ACTING UNUSUAL, FLORES-BUHELOS RELATED THAT THEY THEN PROCEEDED TO SIT IN HER VEHICLE FOR A FEW MINUTES TALKING, WITH VICTIM'S VEHICLE REMAINING IN THE YARD, FLORES-BUHELOS ADVISED THAT SHE THEN OPENED THE PADLOCK ON THE GATE TO THE YARD AND ADVISED VICTIM THAT SHE WAS GOING TO BRING HIM TO THE HOSPITAL FOR MEDICAL TREATMENT DUE TO HIS STATE, FLORES-BUHELOS ADVISED THAT VICTIM STATED THAT HE DID NOT WANT TO GO TO THE HOSPITAL AT WHICH TIME FLORES-BUHELOS ADVISED THAT SHE CONTACTED VICTIM'S FRIEND, CARLO BUONAVOLANTO, AND ADVISED HIM THAT SHE WAS DRIVING VICTIM TO THE HOSPITAL. FLORES-BUHELOS ADVISED THAT CARLO THEN CALLED VICTIM'S BROTHER, CHARLES KELLY, TO ADVISE HIM OF THE ABOVE. FLORES-BUHELOS ADVISED THAT SHE
