ON ARRIVAL, FLORES-BUHELOS ADVISED THAT SHE PROCEEDED TO DRIVE TO THE EMERGENCY ROOM FRONT ENTRANCE AND CONTINUE TO TRY AND TALK VICTIM INTO GETTING MEDICAL ATTENTION. FLORES-BUHELOS ADVISED THAT CARLO ALSO ARRIVED AT THE HOSPITAL AND MET THEM OUTSIDE OF THE EMERGENCY ROOM ENTRANCE. FLORES-BUHELOS ADVISED THAT VICTIM APPEARED TO BE GROGGY BUT WAS IMPROVING. FLORES-BUHELOS ADVISED THAT VICTIM STATED THAT HE HAD INGESTED, "LITTLE PINK PILLS". FLORES-BUHELOS RELATED THAT SHE AND CARLO DISCUSSED BRINGING VICTIM INTO THE HOSPITAL OR DRIVING HIM HOME DUE TO HIS CONDITION IMPROVING. AFTER A FEW MINUTES BOTH FLORES-BUHELOS AND CARLO DECIDED TO DRIVE VICTIM HOME TO FLORES-BUHELOS' RESIDENCE. FLORES-BUHELOS ADVISED THAT UPON DEPARTING THE HOSPITAL THEY DROVE TO THE YARD IN AN ATTEMPT TO LOCATE THE PILLS. ON ARRIVAL, FLORES-BUHELOS, CARLO AND VICTIM ENTERED THE YARD AND EXITED THEIR VEHICLES. UPON DOING SO, FLORES-BUHELOS STATED THAT SHE ENTERED THE TRAILER AND OBSERVED A BOTTLE OF ALEVE AND BOX OF TYLENOL COLD, FLORES-BUHELOS ALSO RELATED THAT SHE COULD SMELL AN ODOR WHICH SHE THOUGHT WAS CARBON MONOXIDE. FLORES-BUHELOS ADVISED THAT SHE THEN LEARNED FROM VICTIM THAT HE HAD ONE OF HIS TRUCKS RUNNING OUTSIDE OF THE TRAILER AND A HOSE LEADING FROM THE EXHAUST OF THE TRUCK INTO THE TRAILER. FLORES-BUHELOS ADVISED THAT SHE AND CARLO TURNED THE TRUCK OFF, SECURED THE TRAILER AND YARD, AND RELOCATED VICTIM TO FLORES-BUHELOS' RESIDENCE. FLORES-BUHELOS STATED THAT AT 1400 HOURS ON THIS SAME DATE SHE PROCEEDED TO WORK.

FLORES-BUHELOS STATED THAT UPON ARRIVING AT THE HOSPITAL SHE DROVE AROUND THE GATE AND TO THE EMERGENCY ROOM ENTRANCE WHERE SHE REQUESTED HELP FROM HOSPITAL STAFF. FLORES-BUHELOS ADVISED THAT VICTIM WAS RELOCATED INTO THE EMERGENCY ROOM WHERE HE RECEIVED MEDICAL ATTENTION. FLORES-BUHELOS ADVISED THAT SHE CONTACTED CARLO, VICTIM'S FRIEND, WHO LATER ARRIVED AT THE HOSPITAL. FLORES-BUHELOS ALSO RELATED THAT SHE CURRENTLY POSSESSES ONE OF VICTIMS CELLULAR PHONES, 312- AS WELL AS THE ORIGINAL NOTE/LETTER AS DESCRIBED ABOVE. ATTORNEY GILLESPIE ADVISED THAT THOSE ITEMS ARE SECURED AT FLORES-BUHELOS RESIDENCE AND WOULD BE TURNED OVER TO R/LT (LISTED ITEMS WERE LATER RECOVERED BY THIS DEPARTMENT ON 09/14/09 AS DOCUMENTED BY DETECTIVE SERGEANT GILBERT'S SUPPLEMENTAL AND SECURED AS EVIDENCE). FLORES-BUHELOS ALSO ADVISED THAT VICTIM'S OTHER CELLULAR PHONE, 708-AND VICTIM'S VEHICLE KEYS ARE IN THE POSSESSION OF MIKE ALLEN, FLORES-BUHELOS ADVISED THAT SHE TENDERED THE ABOVE ITEMS TO ALLEN WHILE AT STROGER HOSPITAL, WITH ALLEN AGREEING TO HANDLE THE RECOVERY OF VICTIM'S VEHICLE. ON LISTED DATE AND TIME R/LT, DETECTIVE MCKINNEY AND CHIEF EVANS PROCEEDED TO THE OFFICE OF ATTORNEY RICK FRIEDMAN, 820 W. JACKSON, #310, CHICAGO, ILLINOIS, REFERENCE INTERVIEW OF MIKE ALLEN. ON ARRIVAL, OFFICERS RELOCATED TO LISTED SUITE NUMBER AND MET WITH ATTORNEY FRIEDMAN AND HIS CLIENT, MIKE ALLEN. AT THAT TIME MIKE ALLEN PROVIDED THE FOLLOWING INFORMATION IN SUMMARY AND NOT VERBATIM: ALLEN RELATED THAT THE LAST TIME THAT HE HAD SPOKEN TO VICTIM WAS ON THURSDAY, 09/10/09, AT WHICH TIME HE ATTEMPTED TO ARRANGE DINNER WITH VICTIM. ALLEN ADVISED THAT VICTIM NEVER RETURNED HIS PHONE CALL. ALLEN RELATED THAT HE HAS KNOWN VICTIM SINCE COLLEGE, WITH VICTIM AND ALLEN ATTENDING THE UNIVERSITY OF ILLINOIS TOGETHER, ALLEN FURTHER ADVISED THAT ON 09/12/09 AT APPROXIMATELY 0400 HOURS HE RECEIVED A TELEPHONE CALL FROM CLARISSA FLORES-BUHELOS. ALLEN ADVISED THAT FLORES-BUHELOS HAD ADVISED HIM THAT VICTIM HAD TAKEN PILLS AND THAT THEY WERE PROCEEDING TO STROGER HOSPITAL. ALLEN FURTHER STATED THAT HE BELIEVED THAT FLORES-BUHELOS HAD ADVISED THAT VICTIM HAD TAKEN TYLENOL AND D-CON. ALLEN ADVISED THAT HE PROCEEDED TO STROGER HOSPITAL AND ON ARRIVAL MET WITH FLORES-BUHELOS AND CARLO BUONAVOLANTO. ALLEN ADVISED THAT UPON SPEAKING WITH FLORES-BUHELOS SHE ADVISED HIM THAT VICTIM SENT HER A TEXT MESSAGE STATING THAT HE HAD TAKEN PILLS AND THAT SHE FOUND VICTIM HUNCHED OVER THE STEERING WHEEL AND VOMIT/FESCES ON HIS CLOTHING. ALLEN ADVISED THAT WHILE WAITING AT LOCATION HOSPITAL STAFF INQUIRED AS TO ANY FAMILY MEMBERS OF VICTIM BEING PRESENT, TO WHICH ALLEN KNEW THE SITUATION WAS NOT GOOD. ALLEN ADVISED THAT UPON SPEAKING WITH FLORES-BUHELOS AND CARLO IT WAS DECIDED THAT ALLEN WOULD CONTACT VICTIM'S WIFE, CARMEN, AND ADVISE HER OF THE ABOVE. ALLEN ADVISED THAT HE CONTACTED VICTIM'S WIFE WHO LATER ARRIVED AT STROGER HOSPITAL. ALLEN RELATED THAT IN THE EARLY MORNING HOURS OF 09/12/09 HE LEFT THE WAITING AREA TO EAT AND CARLO ALSO DEPARTED THE HOSPITAL. ALLEN STATED THAT UPON ARRIVING BACK TO THE WAITING AREA AT APPROXIMATELY 1045 HRS HE LEARNED THAT VICTIM HAD BEEN PRONOUNCED DEAD. ALLEN STATED THAT HE, CARLO (WHO HAD ARRIVED BACK AT THE HOSPITAL), FLORES-BUHELOS, VICTIM'S WIFE CARMEN, AND VICTIM'S SISTER GERTRUDE, REMAINED WITH VICTIM FOR APPROXIMATELY TWO HOURS. ALLEN STATED THAT THEY WERE THEN ADVISED THAT VICTIM HAD TO BE RELOCATED TO THE COOK COUNTY MEDICAL EXAMINERS OFFICE. ALLEN FURTHER STATED THAT HE OFFERED TO RETRIEVE VICTIM'S VEHICLE AND WAS TENDERED THE KEYS TO VICTIMS VEHICLE BY FLORES-BUHELOS, ALLEN ALSO STATED THAT HE RECEIVED VICTIM'S CELLULAR PHONE FROM FLORES-BUHELOS. ALLEN ADVISED THAT HE LATER DEPARTED STROGER HOSPITAL ON 09/12/09 AT APPROXIMATELY 1300 HOURS AND PROCEEDED TO COUNTRY CLUB HILLS IN AN ATTEMPT TO RETRIEVE VICTIM'S VEHICLE. ALLEN RELATED THAT HE WAS GOING TO SECURE VICTIM'S VEHICLE AT THAT LOCATION UNTIL ARRANGEMENTS COULD BE MADE TO CLEAN THE VEHICLE AND RETURN IT TO VICTIM'S FAMILY. ALLEN ADVISED THAT HE LOCATED THE STORAGE YARD AND OPENED THE GATE WHICH HE STATED WAS NOT LOCKED. ALLEN ADVISED THAT UPON ENTERING THE YARD HE PROCEEDED TO VICTIM'S TRAILER IN AN ATTEMPT TO LOCATE A LETTER AND/OR NOTE. ALLEN ADVISED THAT AT THAT TIME HE LOCATED A WHITE COLORED PLASTIC WAL-MART BAG LYING OUTSIDE OF THE TRAILER NEAR THE STAIRS. ALLEN ADVISED THAT WITHIN LISTED BAG WERE BLUE AND WHITE PILLS, OPENED BOTTLES OF ASPIRIN/TYLENOL, AND OPENED AND EMPTY BOXES OF D-CON RAT POISONING. ALLEN STATED THAT HE THEN ENTERED THE TRAILER AND AT THAT TIME OBSERVED A SLEEPING BAG LYING ON THE FLOOR OF THE TRAILER, AN EMPTY GALLON OF MILK AND PHOTOGRAPHS OF VICTIM'S CHILDREN LYING ON THE FLOOR NEAR THE SLEEPING BAG. ALLEN STATED THAT HE WAS UNABLE TO LOCATE A LETTER/NOTE FROM VICTIM. ALLEN ADVISED THAT HE THEN SAT ON THE STAIRS OUTSIDE OF THE TRAILER FOR SEVERAL MINUTES. ALLEN RELATED THAT HE THEN COLLECTED THE WAL-MART BAG WITH THE CONTENTS WITHIN BECAUSE HE DID NOT WANT VICTIM'S FAMILY HEARING ABOUT THESE DETAILS. ALLEN RELATED THAT HE THEN DEPARTED THE YARD IN POSSESSION OF THE DESCRIBED PLASTIC BAG/CONTENTS AND PROCEEDED TO OAK FOREST HOSPITAL WHERE HE ATTEMPTED TO RECOVER VICTIM'S VEHICLE. ALLEN ADVISED THAT HE SPOKE TO HOSPITAL POLICE PERSONNEL WHO REFUSED TO RELEASE THE VEHICLE. ALLEN STATED THAT AFTER BEING UNABLE TO RETRIEVE VICTIM'S VEHICLE HE DEPARTED THE HOSPITAL. ALLEN ADVISED THAT HE LATER MET WITH VICTIM'S WIFE AND TURNED OVER VICTIM'S CELLULAR PHONE AND VEHICLE KEYS TO HER (LISTED ITEMS WERE LATER RECOVERED BY THIS DEPARTMENT ON 09/14/09 AS DOCUMENTED BY DETECTIVE SERGEANT GILBERT'S SUPPLEMENTAL REPORT AND SECURED AS EVIDENCE).

R/LT AND CHIEF EVANS THEN CLARIFIED SOME OF THE DETAILS OF ALLEN'S ACCOUNT OF INCIDENT. AT SAID DATE AND TIME, R/DET-SGT, DET JAMES AND DET THOMPSON WENT TO THE FOREST LUMBER STORAGE YARD, WHICH IS LOCATED ON 173RD STREET JUST WEST OF CICERO, TO ATTEMPT TO LOCATE SOME EVIDENCE AT THE STORAGE YARD REFERENCE THIS CASE. R/DET-SGT AND THE OTHER DETECTIVES CANVASSED THE STORAGE YARD AREA, WHICH HAD A MOBIL TYPE TRAILER LOCATED ON THE WEST SIDE OF THE STORAGE YARD. R/DET-SGT OBSERVED WHAT APPEARED TO BE HUMAN VOMIT AND NUMEROUS PEBBLES OF DCON RAT POISON ON THE GROUND IN CLOSE RANGE IN FRONT OF THE TRAILER. INSIDE OF THE TRAILER WERE 4 PHOTOS WITH EACH PHOTO HAVING A PICTURE OF ONE PERSON, AN OPEN BOX OF DCON RAT/MICE POISON, HUMAN VOMIT AND HUMAN FECES. IT IS UNKNOWN WHO THE PERSONS WERE ON THE PHOTOGRAPHS. THE TRAILER HAD A VERY FOUL ODOR IN IT. THE VICTIM LEASED THE STORAGE YARD SPACE FROM FOREST LUMBER FOR THE BCI COMMERCIAL BUSINESS. R/DET-SGT GOT PAPER WORK TO CONFIRM THAT THE VICTIM WAS THE CONTACT PERSON FOR BCI COMMERCIAL . THE VOMIT THAT R/DET-SGT OBSERVED IN THE STORAGE YARD APPEARED TO BE THE SAME VOMIT THAT R/DET-SGT OBSREVED IN THE FOREST LUMBER PARKING LOT ON 091209. ON LISTED DATE AND TIME R/LT AND DETECTIVE MCKINNEY PROCEEDED TO THE OFFICE OF CARLO BUONAVOLANTO'S ATTORNEY, DONNA ROTUNDA, 1127 SOUTH MANNHEIM #314, WESTCHESTER, ILLINOIS, ON ARRIVAL R/LT AND DETECTIVE MCKINNEY MET WITH ATTORNEY ROTUNDA, ATTORNEY ROBERT NOVELLE AND CARLO BUONAVOLANTO. UPON SPEAKING WITH BUONAVOLANTO HE PROVIDED THE FOLLOWING INFORMATION IN SUMMARY AND NOT VERBATIM: BUONAVOLANTO ADVISED THAT HE HAS BEEN FRIENDS WITH VICTIM FOR APPROXIMATELY 6-7 YEARS AND KNOWS FLORES-BUHELOS THROUGH VICTIM. ON 09/11/09 AT APPROXIMATELY 2212 HOURS BUONAVOLANTO RECEIVED A TEXT MESSAGE FROM CLARISSA FLORES-BUHELOS STATING THAT IT SEEMED LIKE VICTIM WAS IN TROUBLE AND THAT SHE WAS ON HER WAY TO THE HOSPITAL AND ASKED FOR HIS HELP. BUONAVOLANTO RELATED THAT HE THEN PROCEEDED TO OAK FOREST HOSPITAL AND ARRIVED THERE AT APPROXIMATELY 2300 HOURS. ON ARRIVAL HE RELATED THAT HE MET WITH FLORES-BUHELOS WHO ADVISED HIM THAT VICTIM HAD TAKEN "PILLS". UPON SEEING VICTIM, BUONAVOLANTO RELATED THAT VICTIM LOOKED "FAR FROM NORMAL" AND HE FEARED FOR HIS LIFE. BUONAVOLANTO ADVISED THAT WHILE RECEIVING TREATMENT AT THE HOSPITAL VICTIM WAS ADMINISTERED A SHUNT TO HIS GROIN AREA AND KIDNEY DIALYSIS. BUONAVOLANTO ADVISED THAT THE HOSPITAL CONDUCTED A SECOND PROCEDURE OF DIALYSIS ON VICTIM AND LATER DECIDED TO TRANSPORT VICTIM TO STROGER HOSPITAL FOR FURTHER TREATMENT. BUONAVOLANTO STATED THAT WHILE WAITING AT OAK FOREST HOSPITAL FLORES-BUHELOS CONTACTED HER FRIEND, BELIEVED TO BE NAMED NADIA, TO BRING HER SOME CLOTHES BECAUSE SHE ASSUMED SHE WOULD BE STAYING WITH VICTIM. BUONAVOLANTO ADVISED THAT NADIA LATER ARRIVED AT OAK FOREST HOSPITAL, BUONAVOLANTO ADVISED THAT AT APPROXIMATELY 0130 HRS THE HOSPITAL STAFF DECIDED TO TRANSPORT VICTIM WITH THE AMBULANCE ULTIMATELY ARRIVING AT 0415 HRS. BUONAVOLANTO STATED THAT WHILE PREPPING VICTIM FOR TRANSPORT HE BECAME COMBATIVE TO WHICH THE EMERGENCY ROOM DOCTOR ADVISED WAS A NORMAL REACTION TO "POISON". AT THAT TIME R/LT INQUIRED ABOUT THE TERM "POISON" BEING USED BY THE DOCTOR AND BUONAVOLANTO STATED THAT MAYBE HE MEANT "TOXIN".
