UPON SPEAKING FURTHER WITH BUONAVOLANTO HE RELATED THAT ON TUESDAY, 09/08/2009 VICTIM WAS INVOLVED IN A SIMILAR INCIDENT. BUONAVOLANTO RELATED THAT ON LISTED DATE HE RECEIVED A TEXT FROM FLORES-BUHELOS AT APPROXIMATELY 2100 STATING THAT SHE WAS CONCERNED FOR VICTIM AND THAT VICTIM HAD TAKEN PILLS AND SHE ASKED FOR HIS HELP. BUONAVOLANTO WAS ADVISED THAT THEY WERE PROCEEDING TO OAK FOREST HOSPITAL AND HE PROCEEDED TO LOCATION, ARRIVING AT APPROXIMATELY 2200 HOURS. BUONAVOLANTO ADVISED THAT ON HIS ARRIVAL HE MET WITH FLORES-BUHELOS AND VICTIM OUTSIDE OF THE EMERGENCY ROOM ENTRANCE. BUONAVOLANTO ADVISED THAT HE ALSO CONTACTED VICTIM'S BROTHER AND HIS ATTORNEY, MICHAEL MONICO. BUONAVOLANTO RELATED THAT VICTIM APPEARED TO BE OKAY AND LEARNED FROM VICTIM THAT HE HAD "TAKEN THINGS". BUONAVOLANTO ADVISED THAT HE WAS ADVISED THAT VICTIM HAD TAKEN ALEVE AND TYLENOL COLD. BUONAVOLANTO ADVISED THAT VICTIM REFUSED TO GO INTO THE HOSPITAL AND HE AND FLORES-BUHELOS ASSESSED THE SITUATION. BUONAVOLANTO ADVISED THAT AFTER APPROXIMATELY 30-40 MINUTES OF BEING IN THE PARKING LOT THEY DECIDED TO DRIVE VICTIM TO FLORES-BUHELOS' RESIDENCE. BUONAVOLANTO ADVISED THAT HE FOLLOWED FLORES-BUHELOS AND VICTIM TO HER RESIDENCE WHERE THEY ARRIVED AT APPROXIMATELY 0100 HOURS. BUONAVOLANTO ADVISED THAT THEY RELOCATED VICTIM INTO THE RESIDENCE AND HE APPEARED TO BE IMPROVING. BUONAVOLANTO STATED THAT HE REMAINED AT LOCATION FOR AWHILE AND ULTIMATELY DEPARTED, LEAVING FLORES-BUHELOS AND VICTIM AT LOCATION.

AT THAT TIME R/LT CLARIFIED A FEW OF THE DETAILS PROVIDED BY BUONAVOLANTO. R/LT INQUIRED AS TO WHO REMOVED VICTIM'S CLOTHING FROM WITHIN OAK FOREST HOSPITAL TO WHICH BUONAVOLANTO RELATED FLORES-BUHELOS HAD RECOVERED VICTIM'S CLOTHING AND SECURED THEM IN HIS VEHICLE. BUONAVOLANTO ALSO RELATED THAT FLORES-BUHELOS HAD ONE OF VICTIM'S CELLULAR PHONES IN HER POSSESSION. BUONAVOLANTO ALSO CONFIRMED THAT HOSPITAL STAFF HAD REQUESTED DOCUMENTATION WHICH WAS LOCATED IN VICTIM'S POCKETS TO WHICH HE RELATED FLORES-BUHELOS RETRIEVED. BUONAVOLANTO FURTHER ADVISED THAT HE, FLORES-BUHELOS AND VICTIM'S ATTORNEY WERE ATTEMPTING TO GET VICTIM ASSISTANCE AND HELP SINCE THE INCIDENT ON TUESDAY, 09/08/09. BUONAVOLANTO WAS NOT AWARE OF ANY PRIOR THREATS BY VICTIM TO HARM HIMSELF.
