ON THE ABOVE DATE & TIME R/SGT CALLED POLICE CHIEF BOOTH OF STROGER HOSPITAL IN CHICAGO VIA TELEPHONE (REDACTED) REFERENCE OBTAINING SURVEILLANCE VIDEO FROM THE HOSPITAL SURVEILLANCE CAMERA SYSTEM ON THE VICTIM'S VISIT TO THE HOSPITAL. R/SGT WAS ADVISED BY CHIEF BOOTH THAT HE AND HIS INVESTIGATORS WERE UNABLE TO OBTAIN ANY VIDEO ON THE VICTIM AT THE HOSPITAL, DUE TO THE SURVEILLANCE TAPE PLAYER MALFUNCTIONING AND DESTROYING THE TAPES IN THE VIDEO RECORDER PLAYER. 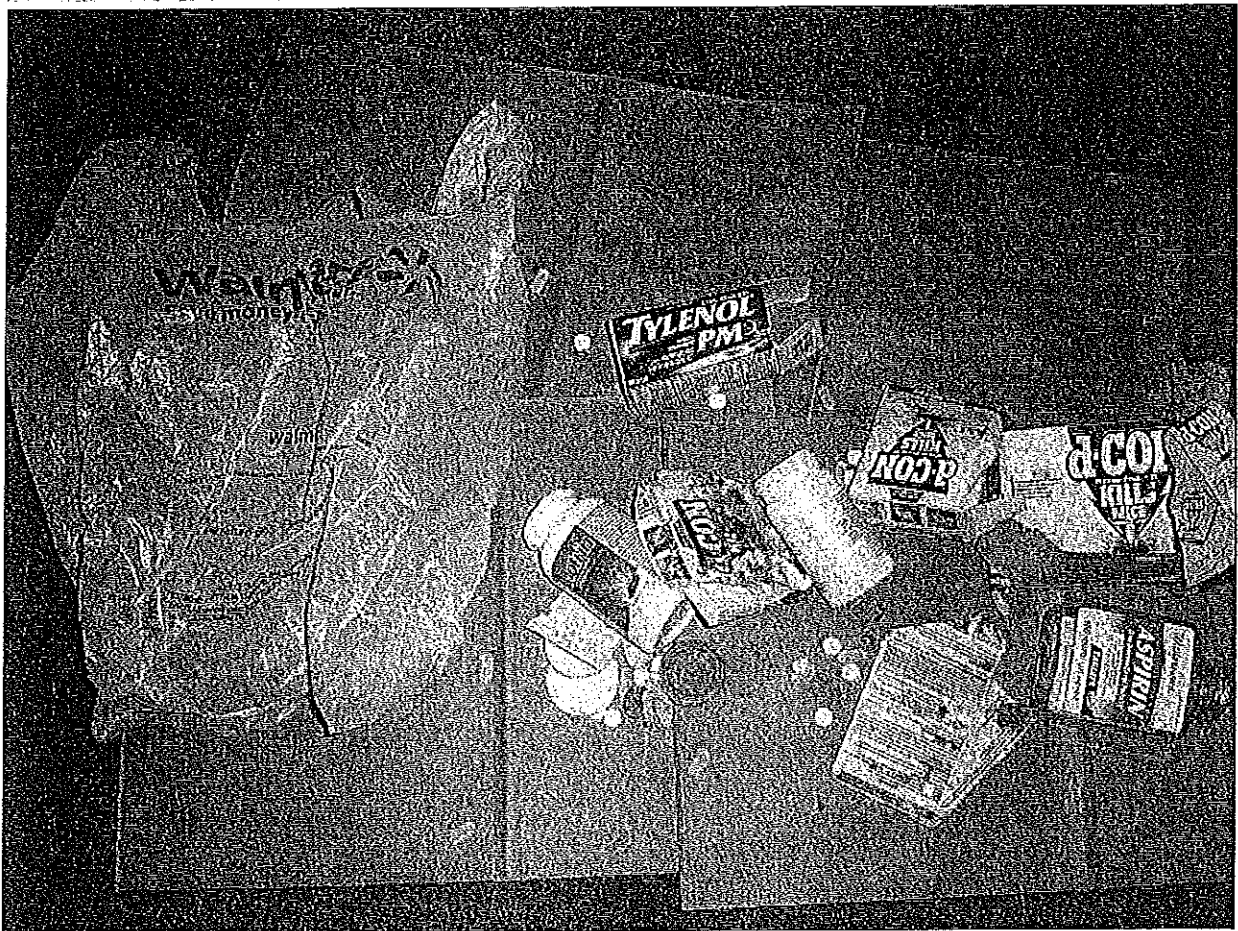

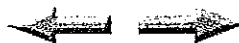
