Supplemental Narrative Topic IN REFERENCE TO ABOVE INCIDENT NUMBER: R ON JUNE 15,2007, I ENTERED GUARDI'S PIZZA FOR A BUSINESS / PERSONAL CHECK. I R WAS ALONE IN THE REAR WITH NO ONE AROUND. MY TASER HOLSTER WOULD NOT LOCK IN Α 1 THE TASER, WOULD NOT SEAT RIGHT. I PULLED THE TASER OUT, STILL NO ONE AROUND, T AND NOTICED THE THE RED DOTTED LIGHT ON AS I POINTED IT AT THE WALL. A FEW SECONDS LATER ALEX EXITED THE COOLER AND AS I LOOKED HIS WAY, I WAS PUTTING Ε THE SAFETY ON, AND IT FIRED IN THE DIRECTION OF ALEX, STRIKING HIM. I DROPPED THE WEAPON AND PULLED THE WIRES AWAY FROM ALEX. I RAN AND HELD ALEX, CATCHING HIM SO HE WOULD NOT FALL. AS WE WENT TO THE FLOOR TOGETHER HE STRUCK HIS HEAD AGAINST THE COOLER DOOR, WHICH WAS STILL OPEN. I WAS YELLING FOR CLARE AND HOLDING ALEX. I IMMEDIATELY CALLED FOR SERGEANT POPP TO RESPOND TO MY LOCATION AND THEN REQUESTED AN AMBUANCE.I REMEMBER OFFICER K. SULLIVAN GETTING THERE DROPPING AN A.E.D. TO THE FLOOR AND RIPPING SOMETHING OPEN. I WAS STILL TALKING TO ALEX WHEN SERGEANT POPP ARRIVED. I BELIEVE THE PARAMEDICS WERE THERE ALREADY. ALEX WAS TRANSPORTED TO PALOS COMMUNITY HOSPITAL FOR TREATMENT. I WAS TRANSPORTED AS WELL FOR HIGH BLOOD PRESSURE.

IN SUMMARY: ON THE ABOVE DATE/TIME, R/O OVERHEARD OFC. VEGA #59 REQUEST AN AMBULANCE TO RESPOND TO THE ABOVE LOCATION FOR A SUBJECT DOWN. R/O ARRIVED ON SCENE AND MET THE VICTIM'S SPOUSE (CLARE) WHO WAS EMOTIONALLY UPSET SCREAMING FOR AN AMBULANCE. R/O ENTERED THE BUSINESS AND LOCATED THE VICTIM LYING ON THE FLOOR NEAR THE FREEZER/COOLERS, CONSCIOUS BUT NOT ALERT. R/O OBSERVED THE VICTIM TO BE BLEEDING FROM A LACERATION LOCATED ON THE RIGHT SIDE OF HIS HEAD. R/O OBSERVED OFC. VEGA KNEELING NEXT TO THE VICTIM, HOLDING HIM TIGHT AND APPLYING PRESSURE TO HIS HEAD INJURY. R/O RETRIEVED MEDICAL GAUZE FROM SQUAD 25A'S MEDICAL KIT AND ASSISTED OFC. VEGA IN APPLYING PRESSURE TO THE VICTIM'S HEAD INJURY. R/O DISCOVERED THAT THE VICTIM WAS ACCIDENTALLY TASED, (TASER X-26, TPPD# X-20, SER# X00-268382), AND FELL DOWN TO THE FLOOR, STRIKING HIS HEAD. TRACE AMBULANCE #275, ARRIVED ON SCENE AND TRANSPORTED THE VICTIM TO PALOS COMMUNITY HOSPITAL FOR TREATMENT. OFC. VEGA WAS SUBSEQUENTLY TRANSPORTED TO PALOS COMMUNITY HOSPITAL BY TRACE AMBULANCE #278 FOR PRECAUTIONARY EVALUATION.

In summary, R/I and Detective McMahon were ordered to Guardi's Pizza, 16711 S. 80<sup>th</sup> Ave, to photograph the scene and collect items of evidence in regards to a Taser discharge. Upon arrival, R/I met with the business owner, Claire Mendez. R/I then photographed the scene in 35 MM format. Mendez then gave her permission for R/I to collect the Sanyo model TLS 4072 Time Lapse Video Recorder that contained one video cassette tape entered into evidence as item #5. R/I also obtained the Taser metal prongs (2) and lead wire from the scene entered into evidence as item # 4 along with the victims eyeglasses entered into evidence as item # 6.

R/I and Detective McMahon then went to Palos Hospital and met with the victim, Alex Mendez. He was photographed at that time. R/I will enter the photographs and negatives into evidence when they are available.
