



CONTINUATION OF "PROBABLE CAUSE"

First Paragraph:

I, DAVID BRITT, have been a law enforcement officer with the Chapel Hill Police Department for approximately four and a half years. I am currently assigned to the Patrol Division. My duties include responding to calls for service, enforcing general statutes and traffic laws, and assisting other divisions within the department in any way possible. Prior to my current assignment, I was assigned to the Northside Unit for three and a half years, where my duties included street-level drug interdiction and assisting narcotics investigators. I am also a member of the Special Emergency Response Team. I have received education and training in drug interdiction, interview and interrogation, narcotics investigation, gang awareness, and search and seizure law, among other things.

Second Paragraph:


On 03/05/2008 at about 0530, Eve Carson's body was discovered by police officers on Hillcrest Drive in Chapel Hill, NC. Carson had been shot to death. A subsequent autopsy was performed by the Office of the Chief Medical Examiner of Chapel Hill. It was determined Carson died as a result of multiple gunshot wounds and her death was ruled a homicide.


Third Paragraph:

The Chapel Hill Police Department initiated a homicide investigation into the death of Eve Carson. The Chapel Hill Police Department requested the State Bureau of Investigation to assist in the ongoing homicide investigation. On 03/11/2008, at 2158, Crimestoppers of Orange County received a call regarding information concerning the homicide of Eve Carson.

Fourth Paragraph:

On 03/11/2008, the caller, who wished to remain anonymous, was interviewed by SA P.A. Stevens of the North Carolina State Bureau of Investigation, concerning that information. The caller advised that during phone conversations with a man she knows as Rio, Rio advised her that he and an unknown individual took Eve Carson to an ATM

Fourth Paragraph (continued):


machine. Rio told the caller that he and the other individual planned to obtain Carson's ATM card PIN from Carson before killing her. A confidential witness known to the caller told the caller that Rio was the man pictured in a photograph being displayed on television news stations in reference to the murder.


Fifth Paragraph:

On 03/12/2008, at about 0709, the confidential witness (hereinafter referred to as CW) was interviewed by ASAC G.W. Tart and SA P.A. Stevens of the North Carolina State Bureau of Investigation. During the interview, the CW identified "Rio" as Demario Atwater. The CW informed investigators that she conversed with Demario Atwater after learning that Atwater's picture was displayed on television. The photograph in question was taken at a BP convenience store, located at 1002 North Alston Avenue in Durham, NC. The photograph was taken on Friday, March 7, 2008, at the same time someone attempted to utilize Eve Carson's ATM card at that BP store, according to bank records. That photo was released to the media in an attempt to identify Atwater, and it was this photograph about which Atwater talked to the CW.

Sixth Paragraph:

The CW informed investigators that Atwater told the CW that he and Alvin Lovette entered Eve Carson's residence through an open door on the date of Carson's murder, which was March 5, 2008. The CW said Atwater told the CW that he and Lovette forced Carson to accompany them to Carson's car and take them to an ATM machine. The CW learned that Carson was forced into the back seat with Atwater, and Lovette drove Carson's vehicle. That information is consistent with video footage taken from an ATM camera on that date. Lovette and Atwater obtained Carson's ATM card PIN number from Carson. The CW informed investigators that Atwater and Lovette obtained approximately \$1400 from Carson's bank account. Investigators can confirm, based on ATM transaction information, that approximately \$1400 was taken from Carson's account, from ATM machines, over a two day period. The CW also informed investigators that Carson was shot multiple times by Lovette and was subsequently shot by Atwater. This information was corroborated by crime scene search information that two separate weapons were used in the homicide of Eve Carson.

Seventh Paragraph:

Carson's cell phone, keys, ATM card, and purse apparently were taken during her kidnapping or after her murder. The keys, ATM card, and purse have not been recovered at this time.

Eighth Paragraph:

The CW informed investigators that Atwater lives at 2507 South Roxboro Street, Apartment 11, in Durham with his mother, Peggy Mabrey. The Durham Housing Authority informed the Chapel Hill Police Department that a Peggy Mabrey lives at 2507 South Roxboro Street, Apartment 11. According to the CW, the last time Atwater was at the above residence was Monday, March 10, 2008 at approximately 1900 or 2000. The CW informed investigators that Atwater has lived at the above address since November, 2007. The CW informed investigators that when Atwater left the above residence, Atwater did not take anything, including evidence, with him and has not been back since March 10, 2008.


Ninth Paragraph:


The CW offered truthful and accurate information, including details regarding the investigation that were not released to the public. Based on information the CW provided during this interview, and due to the fact that many of those details could be corroborated through investigative efforts, it is believed by this affiant that the information provided is truthful and accurate.

Tenth Paragraph:

This affiant has probable cause to believe that Demario Atwater and Lawrence Lovette are responsible for the death of Eve Carson. Arrest warrants have been obtained on Atwater and Lovette for the murder of Eve Carson.

**Due to the above stated facts, I believe probable cause exists to believe evidence of the crimes named above is contained in the property or on the person to be searched named above.**

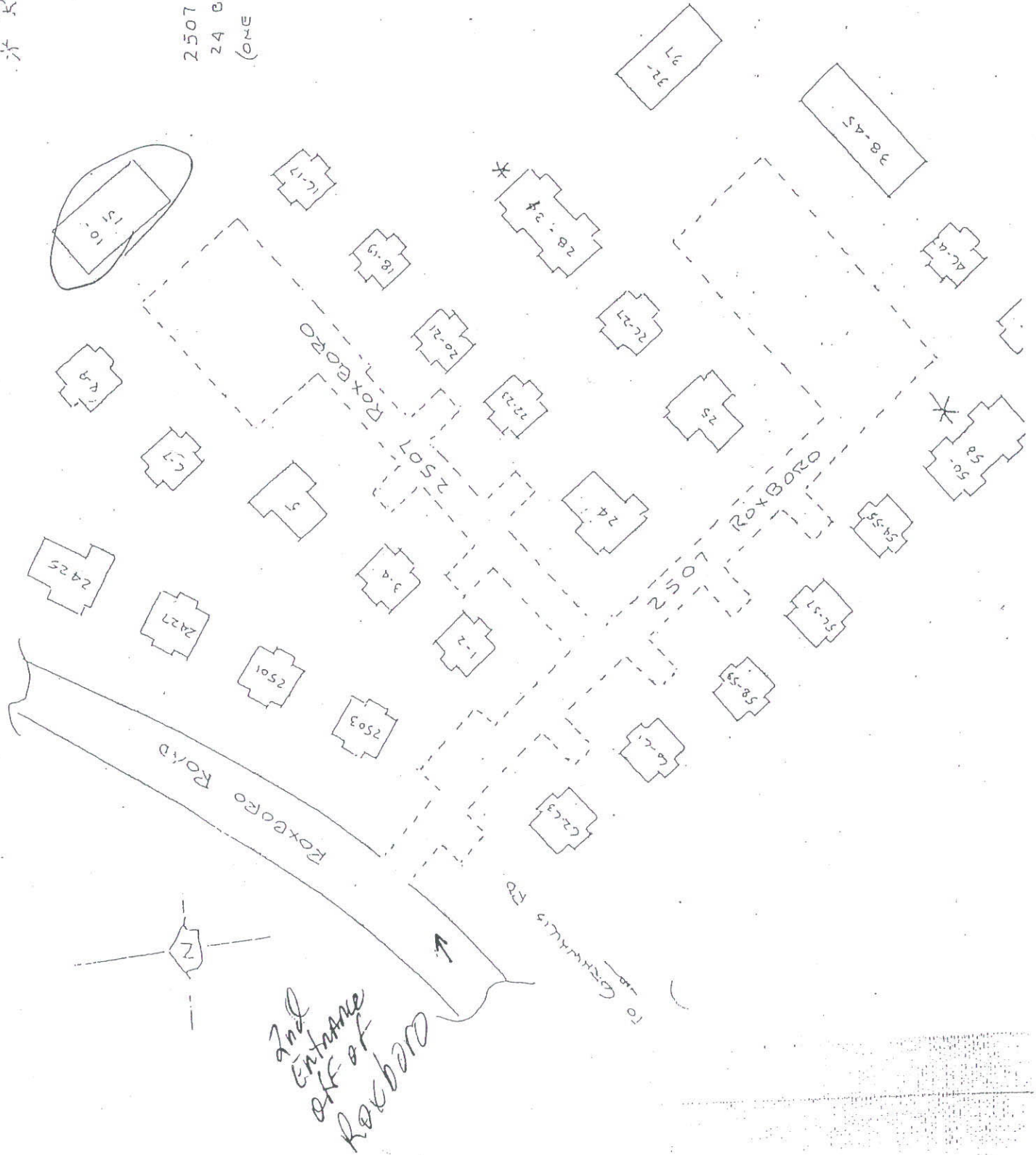
