	On 10/06/14 I (Officer Lane) responded to a breaking and entering at [redacted] England Ave at approximately 1525 hours. Officer Stancil was already on the scene waiting by the garage door when I arrived. I then proceeded to the garage door where the suspect was seen entering the residence. Sgt. Taylor, Officer Stancil, and I made entry into the residence. The garage was cleared and we then proceeded to make entry into the house. The garage door was unlocked and open slightly as we made entry.															
	Sgt. Taylor made entry first and proceeded to the kitchen towards the living room. I followed proceeding towards the dining room and front door area and Officer Stancil was behind me. I made contact with (De'Shawn Currie) who was coming down the stairs. I told Currie to stop and show me his hands. I then asked Currie if he lived here, and he stated yes. I told him to put his hands against the door and Sgt. Taylor began to frisk Currie. I asked Currie if anybody else was in the house and Currie stated "no I am the only person here." Sgt. Taylor looked at Currie's ID and on Currie's ID he had a different address than the address we responded to. The address on the ID was [redacted] North West St. Sgt. Taylor asked Currie why he had a different address on his ID and Currie stated that he had recently moved. Currie was at the bottom of stairs in front of Sgt. Taylor when Officer Stancil walked over and told Currie to have a seat and asked Sgt. Taylor to watch Currie. Currie said to Officer Stancil "man don't yell at me, I will beat your ass." Officer Stancil and I proceeded up the stairs to finish clearing the residence.

Narrative			
Officer Stancil continued into a bedroom while I covered the main area of the upstairs. It was at this time I heard yelling coming from down stairs. Currie was saying "get off me man" and at that time I heard Sgt. Taylor yell "spray." I heard chairs being knocked over and it sounded like a struggle coming from down stairs. Officer Stancil then proceeded back down stairs to assist Sgt. Taylor while I continued to cover the upstairs. Currie was yelling "why the fuck you spray me, I should beat your ass." At that time Currie was secured in handcuffs.			
Officer Stancil continued back up stairs. Officer Stancil and I finished clearing the upstairs where nobody else was found. I proceeded back down stairs to assist with Currie. I helped Currie up to get him outside and Currie was yelling "why the fuck you spray me man, I didn't do nothing to you mother fucker." I walked Currie outside of his residence and told him to have a seat on his front porch. EMS was then called to come decontaminate Currie. While waiting for EMS to arrive, Currie continues to say "fuck you pigs, I hate all of yall mother fuckers, and I should have stayed in Fayetteville." Currie stated that he has lived at this residence since August 2014. Currie stated to me that he was adopted and this was his foster home.			
At approximately 1600 hours EMS arrived. Currie was escorted to the back of the ambulance and EMS started the decontamination process. Currie continued to say "why did you spray me in my own house, this is police brutality." Currie also stated "that he did not want to be man handled and he was only man handled because he couldn't do anything about it. He better be glad I could not hit him." EMS decontaminated Currie for approximately 45 minutes. After Currie was finished with the decontamination process, his demeanor started to settle down. At that time Currie was released to his parents without further incident.

SUPPLEMENT #3 Christopher Gathman - 417 10/06/2014 19:06			
On 10/6/2014 at approximately 1520 hours, I (Lt. C.A. Gathman) responded to ██████ England Avenue in reference to a request for help from officers who were on scene of a possible breaking and entering of a residence. As I was leaving the parking lot of the Fuquay-Varina Police Department, officers on scene advised they were in need of expedited help, and in the background I could hear a loud commotion. The commotion sounded like the officers were struggling with someone inside the residence.			
I arrived on scene a few minutes later and as I was walking up to the front door of the residence, Sgt. Taylor pushed the blinds on one of the front windows out of the way and told me to "hurry up." I entered the residence and in the dining room, I saw Sgt. Taylor restraining a black male on the ground. The black male was in handcuffs and was lying on his stomach. There was a strong odor of pepper spray in the air, and while I was assisting Sgt. Taylor, I was slightly afflicted with the effects of the pepper spray.

Narrative I immediately had Sgt. Taylor exit the residence, and at that time, Ofc. Stancil assisted me in helping the subject onto his feet. The subject, later identified as Mr. De'Shawn Currey, was dealing with the after effects of having been sprayed with pepper spray. I had Mr. Currey moved from inside of the residence out on to the front porch, and I had him sit on the front steps of the porch. Mr. Currey's eyes were closed and he had mucous running out of his nose. Due to Mr. Currey's reaction to the pepper spray, I asked that Wake EMS respond to the scene to decontaminate him and to flush his eyes and face with water.			
While waiting for EMS to arrive on scene, I began to gather information about the incident. I first spoke with the complainant, Mr. Wendell Howerton. Mr. Howerton stated that he had been sitting in his truck in his driveway when he observed a black male walk around the side of 308 England Avenue. Mr. Howerton stated that there have been a number of break-ins in the area and he did not recognize the subject who walked into the residence. Mr. Howerton did state that the residents had only just recently moved in, and that he knew that a white family with small children lived there. Mr. Howerton did state that he had never observed a black male at that residence. Mr. Howerton stated that he was concerned for his neighbors because of the recent residential break-ins and vehicle thefts.			
After talking to Mr. Howerton, I walked back toward █████ England Avenue and I could hear a commotion coming from the front of the residence. Mr. Currey was still sitting on the stairs, however he was yelling and screaming profanities and racial insults toward officers who were standing by. I walked up to Mr. Currey and told him to calm down and stop screaming so he would not get charged with another crime. Mr. Currey continued to curse at me, and said "Fuck you, you racist pig! Don't fucking talk to me!" I continued to tell Mr. Currey to calm down, however that did not work and I eventually just allowed him to sit there by himself.			
EMS #9 arrived on scene a short time later and decontaminated Mr. Currey. While EMS was decontaminating Mr. Currey, his foster mother arrived on scene and confirmed that he was her foster son. I explained the situation to the mother and then notified Chief Smith of the situation.			
SUPPLEMENT #4 David Taylor - 93 10/06/2014 19:10			
On 10/06/2014 at approximately 1520 hours I (Sergeant D. Taylor) responded to █████ England Ave in reference to a breaking and entering into a residence. As I was arriving on the scene Fuquay-Varina Dispatch advised me that a neighbor observed a black male wearing a tee shirt and shorts walking around the home and entered through a door on the side of the garage. Upon my arrival Officer Stancil's marked patrol vehicle was parked on the side of the road and Officer Stancil was standing in the front yard speaking with a male. Officer Stancil then began running toward the garage. Myself and Officer Lane then exited the patrol vehicle that was parked directly behind Officer Stancil's and ran to his location.			
Upon our arrival to Officer Stancil he was standing by the side door of the garage with his gun drawn. The door that Officer Stancil was standing next to was open approximately 4 inches. Officer

Narrative Stancil, myself, and Officer Lane then made entry into the garage. Once inside I identified myself my yelling "Fuquay Police!" Officer Stancil then cleared the garage while I made sure that no one came through the door that went into the home. Once we determined that the garage was clear I then walked up to the door that lead into the home and found that it was also open approximately 4 inches.			
Myself, Officer Stancil, and Officer Lane then made entry into the home. Once inside the home I identified us by yelling, "Fuquay Police!" As we were clearing the kitchen we began to hear foot steps up stairs. I then yelled again, "Fuquay Police!" I then stood at the entrance to the living room while Officer Lane and Officer Stancil looked into the dining room. Once again I yelled, "Fuquay Police!" I then heard the sound of someone running down the stairs and Officer Lane yelled, "Show me your hands!" I then ran into the front foyer to find a black male matching the description given by the caller standing with his hand up. I then placed my pistol back in its holster and walked over to pat down the male. As I approached the male he began yelling. While I was frisking the male (De 'Shawn Currie) Officer Lane asked him what his name was and where he lived. Currie replied, "I live here!" I then located Currie's identification in his back pocket that stated that he lived at 7569 Northwest Street. I then asked Currie why his ID stated that he lived at different address. Currie then stated, "I just moved. I was adopted!" I then had Currie sit down on the steps and Officer Stancil then asked if anyone else was inside. Currie then replied, "No Nigger!" I then attempted to advise Fuquay dispatch of Currie's driver's license number but was unable to due to Currie screaming at officer Stancil. Officer Stancil then told Currie to stand up and sit on a chair at the dining room table just next to the steps. Currie stood up from the stairs but did not sit in the chair. Officer Stancil then told Currie 2 more times to sit in the chair. Currie then stated, "Don't yell at me or I'll beat your ass real quick!" Currie then sat down in the chair. Officer Stancil then asked if I was ok with Currie. I then stated that I was. Officer Stancil and Officer Lane then went upstairs to insure that no one else was in the house.			
Once the officers were upstairs Currie began to yell screaming, "I'm going to beat your fucking asses you fucking pigs!" I advised Currie that he needed to stop using profanity and just stay clam until we could figure out what was going on. Currie then stated, "Fuck you! I'm going to beat your fucking ass and when my dad gets here he is going to beat your ass too!" I then advised Currie again that he needed to stop cursing. Currie then stood up and screamed even louder, "There ain't no body in here didn't I just tell you that you bitch!" I then advised Currie that he needed to sit down or he would be placed into handcuffs. Currie then got about 3 inches from my face and again screamed, "I don't give fuck!" I then grabbed Currie's left hand with my left hand and grabbed my handcuffs with my right. I then attempted to place a handcuff on Currie's left hand. Currie then jerked his hand free from my grasp and struck my left forearm causing me to drop the handcuffs. Currie then yelled, "Don't grab me like that! Now I'm going to beat your ass you stupid pig!" I then grabbed his left hand again and he began to attempt to pull it away from my grasp. With my right hand I then unholstered my pepper spray and sprayed Currie directly in the face. Currie then stopped resisting and fell to the ground. Once he was on the ground I began placing him in handcuffs. Officer Stancil then ran into the room to make sure I was ok and to assist in handcuffing Currie who was actively resisting and would not put his hands behind his back. Officer

Narrative Stancil then returned upstairs to insure that no one was still in the home. While I was with Currie he continued to say that he was going to beat my ass. Lt. Gathman then arrived on scene. Officer Stancil then returned to the dining room with Lt. Gathman. I then left the home to decontaminate myself. Officer Stancil then walked Currie out of the home and set him down and called for Wake County EMS to help in the decontamination of Currie.			
Once Wake County EMS 9 was on scene and began to treat Currie, Currie's mother arrived on scene and stated that yes he did in fact live at the home.			
Captain Adams arrived on scene and spoke with Currie's mother and advised her what took place. After Currie was treated by Wake County EMS he was released to his parents.			
SUPPLEMENT #5 Bryan Stancil - 525 10/06/2014 19:24

On Monday, October 06, 2014, at 1520 hours, I responded to [REDACTED] England Avenue, in reference to a possible breaking or entering. Upon my arrival, I spoke with [REDACTED] (reportee) who resides at [REDACTED] England Avenue, the residence directly across from [REDACTED] England Avenue. [REDACTED] advised me that a black male subject wearing a light colored tank top walked up to the house at [REDACTED] England Avenue and entered the house through the side door. [REDACTED] stated that the door the subject entered through was the entrance to the attached garage of the house. I asked [REDACTED] if he had ever seen the subject before, and he advised me that he had not.			
I approached the door that [REDACTED] advised me that the subject entered through. Sgt. Taylor and Officer Lane arrived on scene and approached the house along with me. I twisted the door knob to check to see if it was unlocked. The door was unsecure. I announced, "Fuquay Police." I then entered the garage and began walking toward the back, clearing it. There were several piles of miscellaneous items on the floor of both sides of the garage; therefore I had to walk all the way to the back of the garage to clear it. I located no one inside the garage.			
As I returned toward the front of the garage, I observed Sgt. Taylor and Officer Lane entering the residence through the door inside the garage. This door led to the kitchen of the house. I heard Sgt. Taylor announce, "Fuquay Police." I entered the kitchen behind Sgt. Taylor and Officer Lane. I announced, "Fuquay Police. If someone is inside, come out and show your hands." I could hear movement upstairs. Sgt. Taylor advised me that he could hear a television. I continued to announce, "Fuquay Police. If someone is inside, come out and show your hands." Officer Lane and I went to the left hallway, and entered the dining room area. At that time, a black male subject wearing a gray tank top and shorts came down the stairs, yelling, "What are you doing in my house?" I advised the subject to show his hands and face the door. The front door to the house was directly in front of the stairs. The subject appeared to be upset, shouting, "Where is your warrant? You can't just come in my house like that! I live here!" I again commanded the subject to face the door and keep his hands up.

Narrative			
While I watched over Sgt. Taylor and the subject, Sgt. Taylor approached the subject and patted him down for any weapons. Sgt. Taylor did not locate any weapons on the subject. Sgt. Taylor located a wallet on the subject, which contained a North Carolina Identification Card, identifying the subject as Mr. Deshawn Currie, with a Falcon, North Carolina address. I had Mr. Currie sit in a chair in the dining room and requested Sgt. Taylor to watch over him, so that Officer Lane and I could finish clearing the house. I then cleared the living room area, and I did not notice a picture of Mr. Currie in there. Officer Lane and I then went up the stairs to clear the second level. While clearing the first room to the left up stairs, I heard Sgt. Taylor and Mr. Currie shouting at each other. I then heard Sgt. Taylor say, "Spray!" I heard Sgt. Taylor's OC spray being administered. I advised Officer Lane to stay and cover down on the rest of the upstairs. I then holstered my duty weapon and ran downstairs. I observed Sgt. Taylor attempting to handcuff Mr. Currie who was lying face down on the dining room floor with his arms clinched underneath his body. I kneeled down and retrieved one of Mr. Currie's arms and brought it behind his back, as Sgt. Taylor brought the other arm behind his back. Sgt. Taylor then applied handcuffs to Mr. Currie. Mr. Currie was shouting and acting very aggressively throughout this encounter, and resisting placing his hands behind his back.			
I stood up and asked Sgt. Taylor if he had control of Mr. Currie, and he advised me that he did. I then returned upstairs and finished clearing the second floor with Officer Lane. We did not locate anyone else inside the residence. I returned to the first floor as Lt. Gathman was walking in the front door. Lt. Gathman and I assisted Mr. Currie to his feet and escorted him to the front porch steps. I sat Mr. Currie down and advised him not to get up. I stood by with Mr. Currie until EMS arrived to decontaminate him from the OC spray. While standing by with Mr. Currie I observed him rocking back and forth in an aggressive manner, and heard him shouting very angrily, obscenities loud enough for several neighbors to hear. Mr. Currie would complain about his face and eyes burning, and then shout toward Officer Lane and I, "You didn't have to fucking spray me and slam me!" Mr. Currie continued to move his attention to and from his face, and to and from Officer Lane and myself until EMS arrived.			
Once EMS arrived, I escorted Mr. Currie to the ambulance. EMS personnel began decontaminating Mr. Currie from the OC spray as he sat on the back step of the ambulance. Mr. Currie continued to express his displeasure with Officer Lane and myself. Mr. Currie's body language was still aggressive as he was stomping his feet and and rocking back and forth. The residents of 308 England Avenue arrived home, and began speaking with Lt. Gathman. I was then advised that Mr. Currie was a resident of [REDACTED] England Avenue, and that he was a foster child of the residents there. Once Mr. Currie was decontaminated, Officer Lane removed the handcuffs from him. Lt. Gathman then advised Mr. Currie that he was free to go, and he returned to the residence. I was then advised by Lt. Gathman to clear the scene.
