#### **Probable Cause Affidavit**

I, Detective K. M. Norman of the Raleigh Police Department, have been employed as a law enforcement officer for more than 16 years. During that time I have been exposed to, investigated and successfully obtained convictions for numerous types of offenses and crimes that include rape, robbery, violent assaults, and homicides. I am currently assigned as a detective with the department's Homicide Unit where I conduct death and homicide investigations. I am familiar that evidence of both physical and forensic nature is often recovered at crimes scenes.

On Thursday 01/27/2011 at approximately 7:00 p.m., detectives with the Raleigh Police Department were conducting a follow-up investigation at the residence located at 4716 Par Vista Court. During that investigation, the detectives were conducting an interview with a male occupant of the residence. A uniformed officer responded to the residence in order to transport the male occupant to a police facility for further investigation. While making preparations to leave the residence, the male occupant retrieved a firearm and engaged in a stand-off with the uniformed officer. During that stand-off, the male occupant shot himself in the head.

I believe probable cause exists to conduct a search at 4716 Par Vista Court Raleigh, North Carolina. It is requested this search warrant be issued in order to seize any and all evidence related to this incident.
