(1) This affiant is a Deputy with the Wake County Sheriff's Office. I have been in Law Enforcement for more than 9 years. I am currently assigned to the Wake County Sheriff's Office Criminal Investigative Division as a Deputy Sheriff Investigator. I have investigated or participated in all aspects of criminal cases including homicides, property crime, sexual offenses, drug violations and domestic violence. Over my years of service I have attended several schools including General Investigations, Interview and Interrogation and Police Law Institute.

(2) On 10/27/2013, Deputy V. Britt was working the NC State Fair at 1025 Blue Ridge Road. Deputy Britt was approached by a male patron inside the Dorton Arena. The patron advised there was a male subject videotaping

males as they used the urinals in the men's restroom. The patron advised Deputy Britt the subject was using a cellular telephone device to record the videos. The patron pointed out the subject and Deputy Britt observed him walking out the door of the Dorton Arena.

(3) Deputy Britt made contact with the subject and she observed him appear to be deleting data from his cellular device. Deputy Britt took possession of the telephone and the subject was detained for further investigation.

(4) The subject was interviewed by Wake County Sheriff's Office Investigators. He confessed to videotaping both men and children in the restrooms located at the NC State Fairgrounds.

(5) The subject advised Investigators that he has similar videos at his residence located at [REDACTED] Raleigh, NC on a "tablet" computer.

(4) Based upon this affiant's training and experience, it is believed the preceding facts establish probable cause to believe the above described items will aid in determining if a crime has been committed at [REDACTED] Raleigh, Wake County, NC or may have further evidence as it relates to the above listed crimes.

For these reasons, this affiant respectfully requests this search warrant.
