LOCATION: 2717-APARTMENT 360 WESTERN BLVD, RALEIGH NC 27606

VIOLATION: DRUG VIOLATION / MARIJUANA

Section I. Description of items to be seized:

Marijuana and items used to prepare marijuana for consumption or to introduce it to the body. Items used to prepare Marijuana for consumption or grind it. Tools and items used to smoke, inhale or ingest Marijuana. Papers, photos or documents that establish ownership or possession of the described items to be seized.

Section II. Name of Crime (s):

Possession of Drug Paraphernalia – NCGS 90.113.22(a)
Possession of Marijuana – NCGS 90.95(a)(4)

Section III. Description of Premise to be Searched:

The apartment to be searched is located at 2717 Western Blvd in Raleigh, North Carolina 27606. This apartment is in an apartment complex known and labeled at the College Inn. It is a four story U-Shaped Building near the intersection of Avent Ferry Rd. Apartment 360 has a green door in an interior hallway labeled 360 in a black square.

Section IV. Probable Cause statement:

I have been a Police Officer for the City of Raleigh, NC for 16 years. During this time, I have received training on how to investigate Drug Offenses. I have completed training on drug identification procedures and participated in a controlled burn of Marijuana for the purposes of recognizing the odor of marijuana. I have seized marijuana and made dozens of arrests that resulted in criminal convictions for possession of Marijuana and Drug Paraphernalia used to consume Marijuana.

On 4/24/2010 at approximately 0100 hours, I was employed as an off-duty officer by the College Inn Apartments located at 2717 Western Blvd, Raleigh NC. This secondary employment is conducted with the approval of the Raleigh Police Department and in compliance with all policies / directives. I am in full uniform and employed to perform rounds of the property. My primary purpose is to deter criminal activity and address any violations I discover.

While walking the hallway of the 3rd Floor, I detected the strong odor of marijuana emanating from the doorway of apartment 360 of the College Inn (2717 Western Blvd, Raleigh NC). I knocked on the door and met the tenants to confirm my observations. A search warrant is needed to lawfully search the apartment and it's occupants for marijuana, paraphernalia to consume marijuana and evidence to establish use possessed said contraband in violation of NCGS 90-95
