ABC11 and Live Nation's VIP Experience to Janet Jackson: State of the World Tour Sweepstakes

OFFICIAL RULES

HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED: A total of two (2) Secondary Prize winners and one (1) Grand Prize winner will be selected via a random drawing from among all eligible Entries received during the Sweepstakes Period. A random drawing will be conducted by the Sponsor and the (3) potential winners ("Winner") will be selected after Entry Deadline at 4:00 pm ET on July 27th. Winners will be contacted by email. Failure to respond to the initial verification phone call and/or email within forty-eight (48) hours after initial notification to the potential Winner or return of the email notification as undeliverable after two (2) attempts will result in disqualification and award of the prize to an alternate winner.
