 ON MONDAY, 12/19/05, AT APPROXIMATELY 1814 HOURS, DEPUTY GIBSON, 5192,
 AND I WERE DISPATCHED TO [REDACTED] FOR A ROBBERY.
 UPON MY ARRIVAL I SPOKE TO WADE GANT, WHO MET ME IN THE FRONT YARD
 OF THE RESIDENCE AND WAS SOAKING WET. WADE GANT TOLD ME HE CAME HOME
 AS NORMAL, PULLING INTO THE GARAGE OF HIS RESIDENCE WHICH IS A DETACHED
 GARAGE NORTH OF HIS RESIDENCE WHERE HE NORMALLY PARKED HIS TRUCK. WADE
 GANT SAID HE BEGAN TO OPEN THE DOOR TO HIS PICKUP TO EXIT HIS VEHICLE
 WHEN HE SAW A HISPANIC MALE ADULT WEARING A BLACK SKI MASK AND A BLACK
 SWEATSHIRT GRAB THE EXTERIOR DOOR HANDLE OF THE DRIVER'S SIDE DOOR WITH
 HIS LEFT HAND, OPENING IT UP AND WITH HIS RIGHT HAND HOLDING A BLACK
 HANDGUN POINTING THE GUN AT WADE GANT'S HEAD.

THE HISPANIC MALE WHO WADE GANT IDENTIFIED AS JESUS MANUEL
 SALGADO, APPROXIMATELY 30 YEARS OF AGE, TOLD HIM TO GET OUT OF THE
 TRUCK AND GET DOWN ON THE GROUND. WADE GANT TOLD ME HE GOT OUT OF HIS
 TRUCK AND LAID DOWN ON HIS STOMACH ON THE FLOOR OF HIS GARAGE. SALGADO
 ASKED WADE GANT "WHERE'S YOUR SON, HE OWES ME LOTS OF MONEY". SALGADO
 ALSO TOLD WADE GANT "HE'S A WORTHLESS PIECE OF SHIT", REFERRING TO WADE
 GANT'S SON. SALGADO ASKED WADE GANT HOW MUCH MONEY HE HAD. SALGADO
 THEN ASKED IF HE HAD A SAFE. WADE GANT TOLD HIM YES. SALGADO ASKED
 HOW MUCH. WADE GANT TOLD HIM HE ONLY HAD \$3,000.00. SALGADO ASKED
 THREE OR FOUR TIMES WHERE WADE GANT'S SON WAS. WADE GANT DID NOT
 ANSWER HIM.

SALGADO THEN ASKED WHERE THE SAFE WAS. WADE GANT TOLD HIM IT WAS
 IN THE HOUSE IN HIS BEDROOM. SALGADO ASKED WHO WAS IN THE HOUSE. WADE
 GANT TOLD HIM HIS WIFE, HIS DAUGHTER AND HER FRIEND WERE INSIDE.
 SALGADO THEN TAPED WADE GANT'S HANDS BEHIND HIS BACK AND ASKED HIM
 WHERE HIS WALLET WAS. WADE GANT TOLD HIM HIS WALLET WAS IN HIS FRONT
 LEFT PANTS POCKET. SALGADO THEN TOOK THE WALLET FROM WADE GANT'S
 PERSON. SALGADO ASKED WADE GANT WHAT HIS PIN CODE WAS TO THE CREDIT
 CARD AND HE SAID, "BETTER TELL ME THE TRUTH BECAUSE I'M TAKING YOUR
 DAUGHTER WITH ME". WADE GANT TOLD ME HE TOLD SALGADO HIS PIN CODE

BECAUSE HE SAID HE WAS TAKING HIS DAUGHTER WITH HIM.
SALGADO THEN ASKED WADE GANT "HOW DID YOU WANT TO DO THIS?" WADE GANT TOLD SALGADO "HOWEVER". SALGADO TOLD WADE GANT HE CAN HAVE HIS TWO FRIENDS GO IN THE HOUSE OR HE AND WADE GANT CAN GO IN. WADE GANT TOLD ME SALGADO HAD TAPED HIS FEET TOGETHER AND TURNED OFF ALL THE LIGHTS IN THE GARAGE WHILE SALGADO WAS ASKING WADE GANT THESE QUESTIONS. WADE GANT TOLD ME SALGADO HELPED HIM UP AND SAID, "IT'S A COUPLE DAYS FROM CHRISTMAS. I DON'T WANT TO HURT ANYBODY."
WADE GANT TOLD ME HE HAS A TELEPHONE IN HIS GARAGE WHICH RINGS WHEN SOMEBODY CALLS HIS RESIDENCE. WADE GANT TOLD ME THE PHONE BEGAN RINGING AND SALGADO THOUGHT IT WAS WADE GANT'S CELL PHONE SO HE TOOK THE CELL PHONE AND THREW IT IN THE BED OF THE PICKUP. WADE GANT TOLD ME SALGADO TAPED UP HIS HANDS AND CUT THE TAPE THAT WAS ON HIS LEGS SO WADE GANT COULD WALK. WADE GANT TOLD ME SALGADO HAD THE HANDGUN POINTED AT HIM AT ALL TIMES, SOMETIMES IN HIS BACK, SOMETIMES ON THE SIDE OF HIS HEAD.

WADE GANT TOLD ME THEY WENT THROUGH THE DOOR WHICH LEADS FROM THE GARAGE TO THE BACKYARD TOWARDS THE HOUSE. WHEN THEY WALKED OUTSIDE OF THE GARAGE, THE MOTION SENSOR LOCATED NEAR THE DOOR OF THE GARAGE ACTIVATED. SALGADO REACHED UP AND UNSCREWED THE LIGHT BULB SO THE LIGHT WAS NOT ON. WADE GANT TOLD ME SALGADO WAS WEARING GLOVES THE ENTIRE TIME.

SALGADO ASKED WADE GANT IF THE BACKDOOR WAS UNLOCKED. WADE GANT TOLD HIM HE DID NOT KNOW. SALGADO TOOK WADE GANT BACK INSIDE THE GARAGE HOLDING THE GUN TO THE BACK OF HIS TORSO AND THE BACK OF HIS HEAD AT DIFFERENT TIMES. WADE GANT TOLD ME SALGADO GOT INTO THE PICKUP TRUCK WHILE HOLDING ONTO WADE GANT'S COAT COLLAR WITH SALGADO'S LEFT HAND. SALGADO GOT THE PHONE OUT OF THE TRUCK. SALGADO ASKED WADE GANT WHAT THE NUMBER TO THE HOUSE WAS. WADE GANT TOLD HIM. SALGADO DIALED THE HOUSE NUMBER ON THE CELL PHONE AND THEN GAVE THE CELL PHONE TO WADE GANT AND TOLD HIM TO TELL HIS WIFE TO UNLOCK THE DOOR, THAT HE HAS GOT A RUG. WADE GANT TOLD ME HE TOLD HIS WIFE THIS AND HIS WIFE SAID, "OKAY". WADE GANT SAW HIS WIFE, KATHLEEN GANT, OPEN THE BACKDOOR. SALGADO FORCED WADE GANT TO THE DOOR WITH HIS LEFT HAND STILL ON HIS JACKET COLLAR AND HIS RIGHT HAND PUSHING THE GUN INTO HIS BACK AND SIDE OF HIS HEAD.

SALGADO PUSHED WADE GANT INTO THE HOUSE AND TOLD WADE GANT TO TELL HIS WIFE TO GET ON THE GROUND. WADE GANT TOLD HER TO AND SHE DID. WADE GANT TOLD ME HIS DAUGHTER CAME OUT OF THE BEDROOM AND THEN SHE WENT BACK IN. SALGADO TOLD WADE GANT TO TELL HER TO GET BACK IN THE ROOM THEY WERE IN. SALGADO PUSHED WADE GANT TO THE HALLWAY AND NOTICED THE BATHROOM LIGHT WAS ON. SALGADO ATTEMPTED TO GAIN ENTRY INTO THE BATHROOM BY ATTEMPTING TO FORCE HIS WAY THROUGH THE DOOR WITH HIS SHOULDER; HOWEVER, HE WAS UNSUCCESSFUL. SALGADO TOLD WADE GANT TO TELL THE PERSON IN THE BATHROOM TO GET OUT. WADE GANT TOLD HIS DAUGHTER'S FRIEND, WHO WAS IN THE BATHROOM, TO COME OUT. WADE GANT TOLD ME SHE CAME OUT OF THE BATHROOM AT THAT TIME.

WADE GANT SAID SALGADO HAD EVERYBODY GO TO HIS BEDROOM AND ASKED WHERE EXACTLY THE SAFE WAS. WADE GANT TOLD HIM IT WAS ON THE OTHER SIDE OF THE BED. SALGADO TOLD WADE GANT TO TELL HIS WIFE TO GET IT. WADE GANT TOLD HIM THE KEYS TO THE SAFE WERE IN HIS TRUCK. SALGADO TOLD WADE GANT'S WIFE TO CARRY THE SAFE BACK TO THE GARAGE. WADE GANT

TOLD SALGADO IT WAS TOO HEAVY FOR HER AND SHE COULD NOT. SALGADO TOLD WADE GANT TO HAVE HER CARRY IT TO THE GARAGE. WADE GANT'S WIFE WAS ABLE TO PICK UP THE SAFE AND CARRY IT THROUGH THE HOUSE THROUGH THE BACKYARD AND SET IT JUST INSIDE THE GARAGE.

SALGADO THEN GOT THE KEYS WHICH WADE GANT BELIEVES WERE ON THE FLOORBOARD OF HIS TRUCK. SALGADO HAD WADE GANT'S WIFE OPEN THE SAFE. WADE GANT TOLD ME IT WAS TAKING HIS WIFE A LONG TIME BECAUSE SHE IS UNFAMILIAR WITH THE SAFE AND HOW THE LOCKING MECHANISM WORKS. SALGADO KEPT YELLING AT HER TO OPEN IT. WADE GANT TOLD SALGADO TO TAKE THE ENTIRE SAFE. SALGADO TOLD WADE GANT NO, JUST GET IT OPEN. WADE GANT'S WIFE WAS ABLE TO OPEN THE SAFE.

SALGADO REACHED IN THE SAFE AND GRABBED A WAD OF CASH AND PUT IT IN THE FRONT POCKET OF HIS BLACK SWEATSHIRT. SALGADO REACHED IN THE SAFE AGAIN AND GRABBED A BLACK PLASTIC BAG WHICH HAD HIS WIFE'S JEWELRY. SALGADO TOLD WADE GANT'S WIFE TO TAKE OFF HER WEDDING RING. WADE GANT'S WIFE DID SO. SALGADO TOLD WADE GANT'S WIFE HE WANTED ALL OF HER RINGS. WADE GANT'S WIFE TOLD SALGADO THAT WAS ALL SHE HAD.

SALGADO TOLD EVERYBODY TO JUMP INTO THE SWIMMING POOL. WADE GANT TOLD ME HIS DAUGHTER AND HIS DAUGHTER'S FRIEND JUMP INTO THE DEEP END WITHOUT HESITATION. WADE GANT'S WIFE WALKED OVER TO THE SHALLOW END AND STEPPED INTO THE POOL, UTILIZING THE POOL'S BUILT IN STEPS. SALGADO TOLD WADE GANT TO GET IN AND STARTED TO PUSH HIM IN TOWARDS THE DEEP END OF THE POOL. WADE GANT TOLD SALGADO THAT HE CANNOT GET INTO THE DEEP END BECAUSE HE CANNOT SWIM WITH HIS HANDS BEHIND HIS BACK AND HE WILL DROWN. SALGADO CYCLED THE HANDGUN BY PULLING THE SLIDE BACK AND LETTING IT GO. WADE GANT SAID HE WENT OVER TO THE SHALLOWER END AND JUMPED IN. SALGADO THEN TOLD WADE GANT "DO NOT CALL THE COPS OR I'LL COME BACK AND KILL YOU".

SALGADO THEN WENT INTO THE HOUSE TOWARDS THE FRONT DOOR. WHEN WADE GANT SAW SALGADO GO IN THE HOUSE HE TOLD HIS WIFE TO GO INTO THE GARAGE AND CALL 911. WADE GANT TOLD ME SHE COULD NOT BECAUSE THERE WERE NO LIGHTS AND COULD NOT FIND THE PHONE, SO SHE WENT INTO THE HOUSE TO CALL 911. WADE GANT TOLD ME THE PHONE WAS DEAD, POSSIBLY BY A PHONE BEING OFF THE HOOK INSIDE THE RESIDENCE. WADE GANT TOLD ME HIS DAUGHTER UNTIED HIM AND THAT IS WHEN HE WENT INTO THE GARAGE AND CALLED 911 UTILIZING A SECOND PHONE LINE.

WADE GANT TOLD ME SALGADO WAS WEARING A BLACK SKI MASK WITH THE EYES AND MOUTH EXPOSED. WADE GANT SAID SALGADO WAS WEARING EITHER A BLACK OR DARK DARK BLUE SWEATSHIRT. IN ANY CASE IT WAS A DARK SWEATSHIRT. WADE GANT SAID THE SWEATSHIRT HAD A FRONT POCKET BUT DID NOT KNOW IF IT WAS A ZIP UP OR NOT. WADE GANT SAID HE SAW SALGADO'S BROWN EYES AND HE POSSIBLY HAD A MUSTACHE. WADE GANT SAID SALGADO'S HAIR WAS ABOUT SHOULDER LENGTH. I ASKED WADE GANT HOW HE KNOWS SALGADO. WADE GANT REPLIED SALGADO WORKED FOR HIM FOR ABOUT TWO YEARS AND RECOGNIZED HIM EVEN THROUGH THE SKI MASK. WADE GANT TOLD ME THE PERSON WHO DID THIS WAS A HISPANIC MALE ADULT WITH A HEAVY ACCENT AND APPROXIMATELY 30 YEARS OLD.

I SPOKE TO WADE GANT'S WIFE, KATHLEEN GANT, WHO TOLD ME THE PHONE RANG AND HER DAUGHTER CAME AND HANDED HER THE PHONE. KATHLEEN SAID IT WAS HER HUSBAND AND HE TOLD HER TO UNLOCK THE BACKDOOR. SHE TOLD ME SHE DID. KATHLEEN TOLD ME SHE HEARD SOME NOISES IN THE GARAGE AND THEN SAW THE LIGHTS GO OUT SO SHE THOUGHT HER HUSBAND WAS COMING IN. SHE

TOLD ME SHE SAW HER HUSBAND COMING OUT OF THE GARAGE INTO THE BACKYARD TOWARDS THE HOUSE AND SAW SOMEBODY THAT WAS BEHIND HIM OFF TO HER HUSBAND'S RIGHT SIDE.

KATHLEEN WAS TOLD BY HER HUSBAND TO GET ON THE GROUND, WHICH SHE DID. KATHLEEN SAID SALGADO TOLD EVERYBODY TO GO IN THE BEDROOM AND HE TOLD HER TO OPEN THE SAFE. KATHLEEN SAID HER HUSBAND SAID THE KEYS WERE IN HIS TRUCK. SALGADO TOLD WADE GANT TO TELL KATHLEEN TO PICK UP THE SAFE. KATHLEEN SAID WADE GANT TOLD SALGADO THE SAFE WAS HEAVY; HOWEVER, SHE WAS ABLE TO PICK IT UP. KATHLEEN CARRIED THE SAFE FROM THE BEDROOM THROUGH THE HOUSE, INTO THE BACKYARD AND SET IT DOWN JUST INSIDE THE GARAGE. SALGADO TOLD WADE GANT TO HAVE HIS WIFE UNLOCK THE SAFE. KATHLEEN SAID IT WAS HARD FOR HER BECAUSE THERE WERE NO LIGHTS ON SO SALGADO OPENED UP THE CELL PHONE AND ILLUMINATED THE LOCK MECHANISM SO KATHLEEN COULD SEE WHERE TO PUT THE KEY. KATHLEEN SAID SHE HAD A HARD TIME OPENING IT, BUT SHE WAS ABLE TO GET IT OPEN. KATHLEEN SAID SALGADO REACHED IN AND GRABBED THE MONEY THAT WAS IN THE SAFE AND PUT IT IN HIS POCKET. KATHLEEN SAID SHE THINKS HE REACHED IN AGAIN AND GRABBED THE RINGS, BUT WAS UNSURE. WE LATER CHECKED THE SAFE FOR THE RINGS THAT WERE IN THE SAFE BUT WERE UNABLE TO FIND THEM.

KATHLEEN SAID SALGADO ORDERED EVERYBODY INTO THE BACKYARD AND TOLD THEM TO GET INTO THE POOL. KATHLEEN SAID HER DAUGHTER AND HER DAUGHTER'S FRIEND JUMPED INTO THE POOL AND THEN SHE WENT OVER TO THE SHALLOW END AND GOT IN. KATHLEEN SAID SALGADO TOLD HER HUSBAND TO JUMP IN THE POOL. KATHLEEN SAID HER HUSBAND TOLD SALGADO HE COULD NOT SWIM WITH HIS HANDS TIED BEHIND HIS BACK BECAUSE HE WOULD DROWN. KATHLEEN SAID SHE SAW SALGADO COCK THE GUN WHILE POINTING IT AT HER HUSBAND'S HEAD. KATHLEEN SAID HER HUSBAND WENT OVER AND JUMPED INTO THE SHALLOWER END. KATHLEEN SAID SALGADO SAID SOMETHING LIKE IF SHE CALLED THE COPS, HE WOULD COME BACK AND GET THEM. KATHLEEN SAID SHE WAS UNSURE OF WHAT HE HAD SAID BECAUSE EVERYTHING WAS HAPPENING SO FAST.

KATHLEEN SAID SALGADO WENT INTO THE HOUSE AND WALKED TOWARDS THE FRONT DOOR. KATHLEEN TOLD ME SALGADO DID NOT RUN, NOR DID HE LOOK BACK. HE SIMPLY JUST WALKED.

KATHLEEN TOLD ME THERE WERE APPROXIMATELY 10 TO 12 RINGS THAT WERE IN THE BAG THAT WAS TAKEN FROM THE SAFE, ALONG WITH A TENNIS BRACELET. KATHLEEN SAID SALGADO TOLD HER TO TAKE OFF HER WEDDING BAND AND GIVE IT TO HIM. KATHLEEN TOLD SALGADO "YOU WANT MY WEDDING BAND?" SALGADO SAID YEAH. KATHLEEN TOOK OFF HER WEDDING RING AND PLACED IT IN THE PALM OF HER HAND, AT WHICH TIME SALGADO GRABBED IT FROM HER.

WADE GANT HAD PURCHASED THE JEWELRY ITEMS FOR HIS WIFE, KATHLEEN, AND VALUED THE RINGS AT APPROXIMATELY \$7,500.00. THE TENNIS BRACELET WAS VALUED AT APPROXIMATELY \$1,000.00, AND THE DIAMOND RING AT APPROXIMATELY \$2,500.00. WADE GANT TOLD ME HE HAD JUST COUNTED THE MONEY IN HIS SAFE JUST THE OTHER DAY. WADE GANT TOLD ME THERE WERE \$26,000.00 IN \$100 BILLS, \$80.00 IN \$5 BILLS, \$90.00 IN \$10 BILLS AND THE REST OF THE BALANCE OF \$30,000.00 WAS IN \$20 BILLS. WADE GANT TOLD ME HE HAD APPROXIMATELY \$500.00 IN HIS WALLET WHICH WAS TAKEN BY SALGADO.

I SPOKE TO WADE GANT'S DAUGHTER, KATRINA JEANNIE GANT, WHO TOLD ME SHE WAS IN HER BEDROOM WHEN HER DAD CALLED ON THE PHONE. KATRINA TOLD ME SHE WAS TALKING TO HER FRIEND AND HEARD A BEEP INDICATING A CALL WAITING SO SHE SWITCHED OVER AND NOTICED IT WAS HER DAD. HER DAD TOLD

HER TO GIVE THE PHONE TO HER MOTHER. KATRINA SAID SHE DID.
KATRINA TOLD ME SHE HAD GOTTEN THE PHONE AND WENT BACK INTO THE ROOM TO CALL HER FRIEND AGAIN WHEN SHE NOTICED SALGADO WAS IN THE LIVING ROOM AND HE HAD A GUN TO HER FATHER. SHE TOLD ME SALGADO TOLD HER TO GO INTO HER ROOM AND SIT IN THE CORNER AND THEN TOLD HER DAD TO TELL HER MOTHER TO GET THE SAFE. HER MOTHER GOT THE SAFE AND THEN SALGADO TOLD EVERYBODY TO GO BACK OUTSIDE TO THE GARAGE.

KATRINA SAID THEY DID AND SALGADO HAD GOT THE KEYS FROM THE TRUCK AND TOLD HER MOTHER TO OPEN UP THE SAFE. KATRINA SAID SHE NOTICED THE GUN WAS BLACK AND HE WAS POINTING IT AT HER DAD AND SOMETIMES AT HER MOTHER, TELLING HER MOTHER TO OPEN THE SAFE. KATRINA WAS SCARED SO SHE LOOKED AWAY AND DID NOT WANT TO LOOK AT THE GUN. KATRINA SAID IT WAS TAKING HER MOTHER A LITTLE WHILE TO OPEN THE SAFE BECAUSE IT WAS DARK. SHE SAID SALGADO WAS HOLDING A CELL PHONE TO LIGHT UP THE LOCK. KATRINA SAID THE CELL PHONE WENT DARK SO SHE TOLD SALGADO TO PUSH THE BUTTON ON THE SIDE AND IT WOULD COME BACK ON. SALGADO THEN CLOSED THE CELL PHONE AND OPENED IT BACK UP WHICH REACTIVATED THE BACK LIGHT.

KATRINA SAID SALGADO HAD GOTTEN THE MONEY OUT OF THE SAFE AND TOLD EVERYBODY TO GO INTO THE BACKYARD AND JUMP INTO THE POOL, WHICH SHE DID. KATRINA SAID SHE SWAM OVER TO THE SIDE OF THE POOL WHERE A ROCK WAS AND HELD ON THERE. KATRINA SAID IT WAS AFTER THAT THAT HER MOM WENT TO CALL 911, SO SHE UNTIED HER DAD.

I THEN SPOKE TO KATRINA'S FRIEND, ELIZABETH MARIA NUNEZ, WHO TOLD ME SHE WAS IN THE BATHROOM WHEN SHE OPENED THE DOOR AND SAW A MAN WITH A GUN IN THE HOUSE, SO SHE CLOSED THE DOOR. ELIZABETH SAID WADE GANT TOLD HER TO OPEN THE DOOR AND THE MAN TOLD HER AND KATRINA TO SIT AT THE CORNER OF THE ROOM WHILE HER MOTHER GOT THE SAFE.

ELIZABETH SAID THE GUY TOLD EVERYBODY TO GO OUT INTO THE GARAGE, WHICH THEY DID. THEY WENT TO THE GARAGE WHERE KATRINA'S MOTHER WAS TRYING TO OPEN THE SAFE. ELIZABETH TOLD ME AFTER KATRINA'S MOM HAD OPENED THE SAFE THE MAN ORDERED THEM TO JUMP IN THE POOL. ELIZABETH SAID THEY JUMPED INTO THE POOL AND THEN SWAM TO THE SIDE.

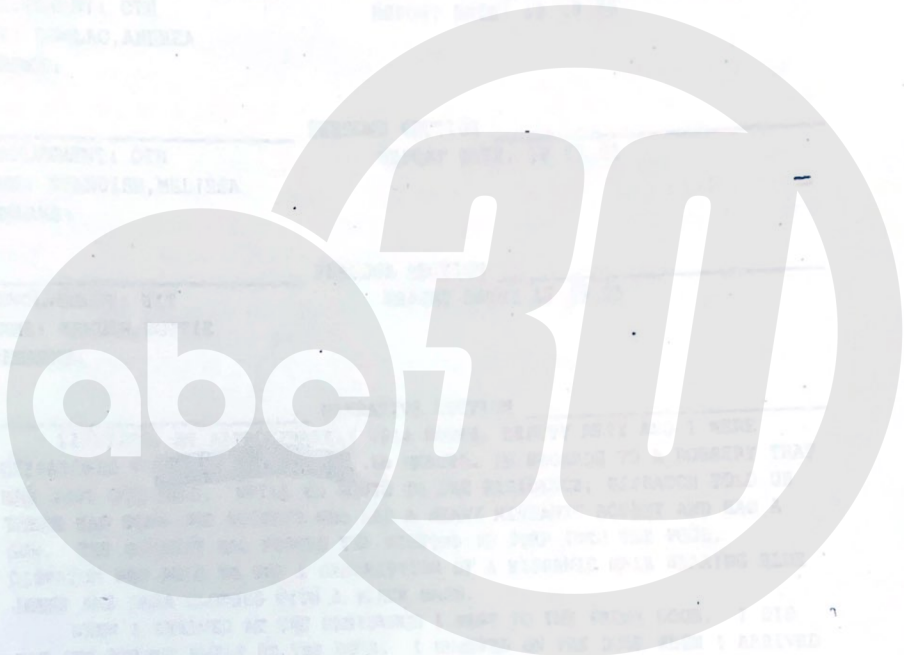

THE RESIDENCE. I ASKED ANDREA IF SHE HAD BEEN OUTSIDE RECENTLY. ANDREA SAID SHE HAD BEEN OUT WORKING ON HER TRUCK BECAUSE IT HAD BEEN VANDALIZED. I ASKED ANDREA IF SHE HAD SEEN ANY SUSPICIOUS PERSONS OR ACTIVITY IN THE AREA THAT EVENING AND SHE TOLD ME NO. I ASKED HER IF SHE HAD SEEN ANY OTHER VEHICLES THAT SHE NORMALLY DOES NOT SEE AND SHE ALSO TOLD ME NO. ANDREA EXPLAINED SHE WAS A GIRLFRIEND OF A RESIDENT AT THE HOUSE. I ASKED ORNELAS WHERE SALGADO WAS LAST NIGHT AND SHE TOLD ME THAT HE WAS HOME WITH IRENE LAST NIGHT. ORNELAS TOLD ME THAT SHE WENT TO WORK ON 11/19/2005 AT 1500 HOURS AND CAME HOME AT 2300 HOURS. ORNELAS TOLD ME THAT WHEN SHE GOT HOME SALGADO WAS ASLEEP ON THE COUCH. I ASKED HER IF SALGADO EVER LEFT THE PROPERTY AND SHE TOLD ME THAT SALGADO CAME OVER AND ASKED HER IF SHE COULD WATCH IRENE FOR A LITTLE BIT. SALAZAR TOLD ME THAT SALGADO WAS GONE FOR AT LEAST AN HOUR. I ASKED SALAZAR WHAT TIME THIS HAPPENED AT AND SHE TOLD ME THAT IT WAS SHORTLY AFTER DARK. I ASKED SALAZAR WHAT SALGADO WAS WEARING WHEN HE LEFT AND SHE TOLD ME THAT HE WAS WEARING DARK BLUE JEANS AND A LONG SLEEVE BLACK SHIRT.

DUE TO SALGADO'S INCONSISTENT, I ASKED HIM IF HE WOULD BE WILLING TO COME TO THE SHERIFF'S DEPARTMENT TO SPEAK WITH US FURTHER AND HE TOLD ME THAT HE WOULD. SALGADO WAS TRANSPORTED TO THE SHERIFF'S DEPARTMENT BY DETECTIVES CLINTON AND JEW.

IN A TAPE-RECORDED INTERVIEW, SERGEANT GOINS AND I SPOKE WITH SALGADO. I EXPLAINED TO SALGADO THAT HE WAS NOT UNDER ARREST AND THAT HE WAS FREE TO LEAVE AT ANYTIME. I ASKED SALGADO TO TELL ME WHAT HE DID YESTERDAY. SALGADO TOLD ME THAT HE GOT UP AT 0800 HOURS AND GOT HIS TWO KIDS, ELINA AND EZEKIAL, READY TO GO TO THEIR GRANDMOTHER'S HOUSE IN WINTON. SALGADO TOLD ME THAT HE HAD LINDA WATCH IRENE IN THE MORNING WHEN HE DROVE TO WINTON. SALGADO TOLD ME THAT HE CALLED "FOSTER FARMS" ABOUT A JOB FROM WINTON, THEN HE DROVE BACK TO HIS RESIDENCE. SALGADO TOLD ME THAT HE WAS HOME FOR THE REST OF THE TIME.

I EXPLAINED TO SALGADO THAT I HAD SPOKEN WITH LINDA AND SHE TOLD US THAT HE LEFT IRENE WITH HER AND THAT HE LEFT. SALGADO TOLD US THAT HE DID NOT LEAVE AT ANYTIME. I ASKED SALGADO WHY LINDA WOULD TELL US THAT HE LEFT AND HE TOLD ME THAT THE ONLY TIME THAT HE LEFT WAS AT 1000 HOURS WHEN HE WENT TO WINTON AND HE ASKED LINDA TO WATCH IRENE AT THAT TIME. I EXPLAINED TO SALGADO THAT LINDA TOLD US THAT THIS HAPPENED AT NIGHT AND HE TOLD ME THAT HE WAS SICK AND DID NOT LEAVE HIS HOUSE.

I ASKED SALGADO FOR THE ADDRESS OR PHONE NUMBER FOR DIANA AND HE COULD NOT GIVE IT TO ME. I ASKED SALGADO IF HE WAS WILLING TO TAKE US TO THE ADDRESS SO WE COULD CONFIRM HIS STORY AND HE TOLD US THAT HE WOULD NOT, AND THAT HE DID NOT WANT TO SPEAK WITH US ANY FURTHER ABOUT THIS INCIDENT.

DUE TO SALGADO'S INCONSISTENT STATEMENTS, THE VICTIM'S STATEMENTS, AND DUE TO THE FACT THAT HE CAN NOT PROVIDE AN ALIBI FOR THE HOURS OF 1700 TO 1900 ON 12/19/2005, SALGADO WAS ARRESTED AND BOOKED FOR 211PC, ROBBERY; 459PC, BURGLARY; AND 422PC, CRIMINAL THREATS.

SERGEANT GOINS AND I WENT TO [REDACTED] TO SPEAK WITH SALAZAR. WE TOLD SALAZAR THAT SALGADO HAD BEEN ARRESTED AND THAT WE NEEDED TO GET THE RING THAT HE GAVE TO NASCIMENTO. SALAZAR TOLD US THAT SHE DIDN'T KNOW WHAT WE WERE TALKING ABOUT AND THAT NASCIMENTO AND SALGADO DID NOT SPEAK LAST NIGHT.

SERGEANT GOINS AND I WENT TO "MCCLAIN PACIFIC" AND SPOKE WITH RICHARD NASCIMENTO. I EXPLAINED TO NASCIMENTO THAT SALGADO WAS IN JAIL AND HE TOLD US ABOUT THE RING THAT HE GAVE TO HIM. I EXPLAINED TO NASCIMENTO THAT WE BELIEVED THAT THE RING WAS STOLEN AND THAT HE WAS NOT IN TROUBLE, BUT THAT WE NEEDED TO GET THE RING BACK. SERGEANT GOINS AND I WENT BACK TO [REDACTED] AND SPOKE WITH SALAZAR. I ASKED SALAZAR IF SHE HAD THE RING AND SHE TOLD ME THAT SHE DID. SALAZAR PULLED A RING OUT OF HER LEFT JACKET POCKET AND GAVE IT TO US. SALAZAR TOLD US THAT SHE KNEW ABOUT THE RING, BUT DID NOT WANT TO GET NASCIMENTO INTO TROUBLE. THE RING THAT SALAZAR GAVE US WAS A GOLD BANDED RING WITH NUGGETS NEAR THE TOP. IT HAS A SILVER CLUSTER AROUND A BLUE STONE IN THE SHAPE OF A HEXAGON.

I SPOKE WITH GANT OVER THE TELEPHONE AND I ASKED HIM IF HE HAD A GOLD RING WITH A BLUE STONE STOLEN AND HE TOLD ME THAT HE DID. I MET WITH GANT AT HIS RESIDENCE AND I ASKED HIM TO DESCRIBE THE RING TO US. GANT TOLD ME THAT THE RING HAD A BLUE AND WHITE STONE IN THE SHAPE OF A HEXAGON ON A GOLD BAND. GANT TOLD ME THAT THE BAND WAS SMOOTH NEAR THE BOTTOM AND ROUGH TOWARDS THE TOP. I SHOWED GANT THE RING AND HE TOLD ME THAT IT WAS HIS RING AND IT HAD BEEN STOLEN THE NIGHT BEFORE IN THE ROBBERY.

I ASKED GANT TO DESCRIBE THE CLOTHING THE SUSPECT WAS WEARING AND HE TOLD ME THAT HE WAS WEARING A BLACK HOODED SWEATSHIRT WHICH HAD THE POCKETS IN THE FRONT. GANT ALSO TOLD ME THAT HE WAS WEARING A PAIR OF DARK BLUE JEANS.

IN A VIDEO TAPED INTERVIEW, SERGEANT GOINS AND I INTERVIEWED SALGADO AGAIN. I READ SALGADO HIS MIRANDA RIGHTS FROM MY DEPARTMENT ISSUED MIRANDA CARD AND SALGADO TOLD ME THAT HE UNDERSTOOD HIS RIGHTS. I EXPLAINED TO SALGADO THAT WE SPOKE WITH NASCIMENTO ABOUT THE RING THAT HE GAVE TO HIM AND THAT THE RING WAS STOLEN IN THE ROBBERY.

I ASKED SALGADO TO EXPLAIN HOW HE CAME INTO POSSESSION OF A RING THAT WAS TAKEN THE NIGHT BEFORE IN A ROBBERY FROM HIS EX BOSSES' HOUSE. SALGADO TOLD ME THAT A SUBJECT BY THE NAME OF MARIO ESPINOZA CAME TO

HIS RESIDENCE AND TOLD HIM THAT HE RIPPED SOMEONE OFF. SALGADO TOLD ME THAT ESPINOZA TRIED TO SELL HIM SOME JEWELRY AND HE TOLD HIM THAT HE DIDN'T WANT ANYTHING TO DO WITH IT. SALGADO TOLD ME THAT HE TOLD ESPINOZA TO CHECK WITH NASCIMENTO. I TOLD SALGADO THAT NASCIMENTO SAID THAT HE GAVE THE RING TO HIM AND SALGADO TOLD US THAT HE DID NOT GIVE THE RING TO NASCIMENTO.

DETECTIVE JEW AUTHORED A SEARCH WARRANT FOR THE RESIDENCES OF [REDACTED] AVENUE AND [REDACTED] AVENUE. THE SEARCH WARRANT WAS SIGNED BY THE HONORABLE JUDGE KIRIHARA. THE WARRANT WAS SERVED ON 12/20/2005 AT APPROXIMATELY 1930 HOURS.

I SPOKE WITH ALBERTO SALGADO, DOB 09/14/1981. ALBERTO WAS ON THE HOME MONITORING SYSTEM THROUGH THE MERCED COUNTY JAIL AND IS CONSIDERED AS IN-CUSTODY. ALBERTO WAS EXTREMELY UNCOOPERATIVE WITH OUR INVESTIGATION AND WOULD NOT TALK TO US. I SPOKE WITH CORRECTIONAL OFFICER TUCKER JR, WHO TOLD US TO "ROLL UP" ALBERTO AND TAKE HIM TO JAIL.

UPON SEARCHING [REDACTED] AVENUE, I LOCATED THE FOLLOWING ITEMS:

1. PLASTIC CONTAINER CONTAINING TWO SEPARATE BAGS OF COCAINE, A BAG OF MARIJUANA, AND A SCALE.
2. 22-CALIBER WINCHESTER MODEL 77 RIFLE WITH A PISTOL GRIP.
3. INDICIA CONSISTING OF MAIL IN THE NAME OF RICHARD W. NASCIMENTO.

ALL ITEMS WERE COLLECTED BY ME AND LATER LOGGED INTO EVIDENCE AT THE MERCED COUNTY SHERIFF'S DEPARTMENT. DETECTIVE CLINTON ARRESTED NASCIMENTO FOR POSSESSION OF THE NARCOTICS. FOR MORE INFORMATION ON HIS INVESTIGATION, REFER TO MERCED COUNTY SHERIFF'S DEPARTMENT CASE NUMBER 05 45425.

3. INDICIA CONSISTING OF MAIL IN THE NAME OF JESUS SALGADO.

THE BLUE JEANS AND BLACK HOODED SWEATSHIRT WERE LOCATED IN SALGADO'S BEDROOM, AND ORNELAS TOLD US THAT THE CLOTHES BELONGED TO SALGADO. BOTH THE JEANS AND THE SWEATSHIRT MATCHED THE DESCRIPTION OF THE CLOTHING WORN BY THE SUSPECT.

PHOTOGRAPHS OF THE ITEMS SEIZED WERE TAKEN BY DETECTIVE MUSSOTTO, AND A DISC OF THOSE PHOTOS WAS TURNED OVER TO ME. I LATER LOGGED THE PHOTOS, THE INTERVIEW TAPES AND VIDEO INTO EVIDENCE AT THE MERCED COUNTY SHERIFF'S DEPARTMENT. I LATER PHOTOGRAPHED THE RING AND RETURNED IT TO GANT.
