At this time, I am not available for a sit down interview. I do want to go on record ~~as stating that some of your questions surround an incident that was previously~~ investigated and deemed unfounded. Nothing has changed. The questions you are asking have nothing to do with my June 30<sup>th</sup> arrest. I find the timing of your "investigation" suspicious. I also find it suspicious and slanderous for you to call several organizations I am affiliated with and while asking for financial information you also volunteer the information about my arrest. One has nothing to do with the other. I am not guilty of the charges stemming from that June 30<sup>th</sup> incident nor am I guilty of any other wrongdoing. I hope this is not an attempt by your station to unjustly attack my credibility and distract from the good work I am doing and will continue to do on behalf of the people in my district.

You keep asking for receipts concerning work on my home. For some reason, I do not believe anything I give you would satisfy your quest to make something out of nothing. My home has not been remodeled since being built in 2007. The reimbursement check written to my wife from CBIC was for expenses we paid out of our own pockets. Our mortgage company approved that reimbursement. You are obviously getting information from someone who has a vendetta against me and is using the recent incident to get attention.

Concerning Phoenix Outreach Youth Center, I no longer have a managerial or board position with Phoenix Outreach, so it is pointless for you to keep requesting financial information concerning the center. There is also nothing unusual about me stopping by a center that still remains a hub for the community.

Again, I have never used my position to get any financial gains for my family or me. That includes the fact that I pay for uniforms and equipment my son uses when he plays sports. There is no story here. I will ask you to respect the privacy of my wife and children. They are not public figures.
