Commutation of Sentence Rogel L. Aguilera-Mederos

Pursuant to the authority vested in the Governor of the State of Colorado by Article IV, Section 7 of the Colorado Constitution, I, Jared Polis, Governor of the State of Colorado, hereby issue this Executive Order commuting the sentence of Rogel L. Aguilera-Mederos.

I. Background

In 2021, Rogel L. Aguilera-Mederos, DOC Reg. No. 193007, was sentenced to the Department of Corrections for 110 years for six counts of First Degree Assault–Extreme Indifference and ten counts of Criminal Attempt–First Degree Assault–Extreme Indifference in Jefferson County, Colorado (19CR1608). His current estimated parole eligibility date is in 2091. The constitutional and statutory conditions for granting this clemency petition have been satisfied, and granting this commutation is in the interest of justice.

II. Grant of Clemency

- A. Rogel L. Aguilera-Mederos be and hereby is granted a commutation such that his sentence is commuted to 10 years in the custody of the Department of Corrections. He shall be parole eligible effective December 30, 2026.
- B. This grant of clemency is limited to the commutation granted in Section II.A. of this Executive Order, and this grant of clemency shall not in any way affect the underlying criminal conviction.

EXECUTIVE ORDER

Commutation of Sentence Ronald Johnson

Pursuant to the authority vested in the Governor of the State of Colorado by Article IV, Section 7 of the Colorado Constitution, I, Jared Polis, Governor of the State of Colorado, hereby issue this Executive Order commuting the sentence of Ronald Johnson.

I. Background

In 1999, Ronald Johnson, DOC Reg. No. 53475, was convicted of Organized Crime Control Act, Theft F-3, Theft F-4, Theft F-5, Forgery, Drug Abuse, and Possession of a Financial Transaction Device (98CR3092). He was sentenced to the Department of Corrections for 96 years for these crimes. His current estimated parole eligibility date is in 2027. The constitutional and statutory conditions for granting this clemency petition have been satisfied, and granting this commutation is in the interest of justice.

II. Grant of Clemency

- A. Ronald Johnson be and hereby is granted a limited commutation such that he is granted parole effective January 15, 2022. The Parole Board shall set the terms and conditions of Mr. Johnson's parole, although Mr. Johnson shall be permitted to serve his parole period in Arkansas if approved under the Interstate Compact for Adult Offender Supervision. In this case, the Colorado Department of Corrections shall work with the Arkansas Department of Corrections to manage the terms and conditions of Mr. Johnson's parole.
- B. This grant of clemency is limited to paroling Mr. Johnson effective January 15, 2022, with terms and conditions of parole to be set by the Parole Board, and shall not in any way affect the underlying criminal conviction.

He was sentenced as a habitual offender to the Department of Corrections for 48 years for these crimes. His current estimated parole eligibility date is in 2029. The constitutional and statutory conditions for granting this clemency petition have been satisfied, and granting this commutation is in the interest of justice.

II. Grant of Clemency

- A. Nicholas Wells be and hereby is granted a limited commutation such that he shall be parole eligible on January 15, 2022.
- B. This grant of clemency is limited to making Mr. Wells parole eligible on January 15, 2022, and shall not in any way affect the underlying criminal sentence.

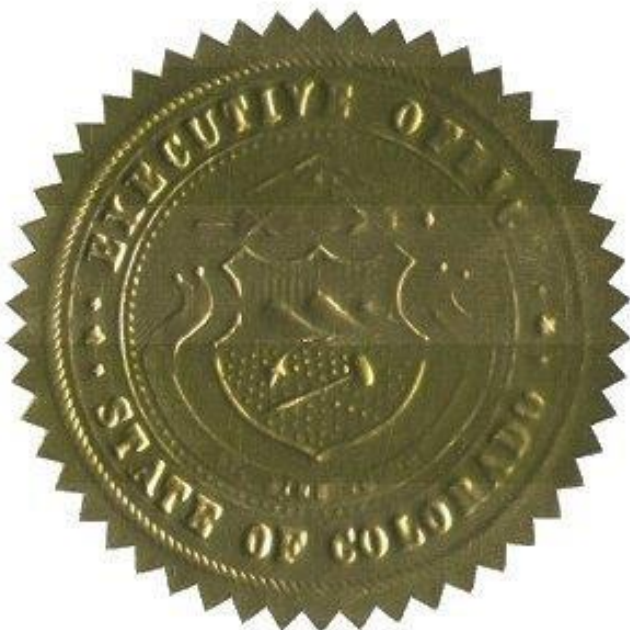

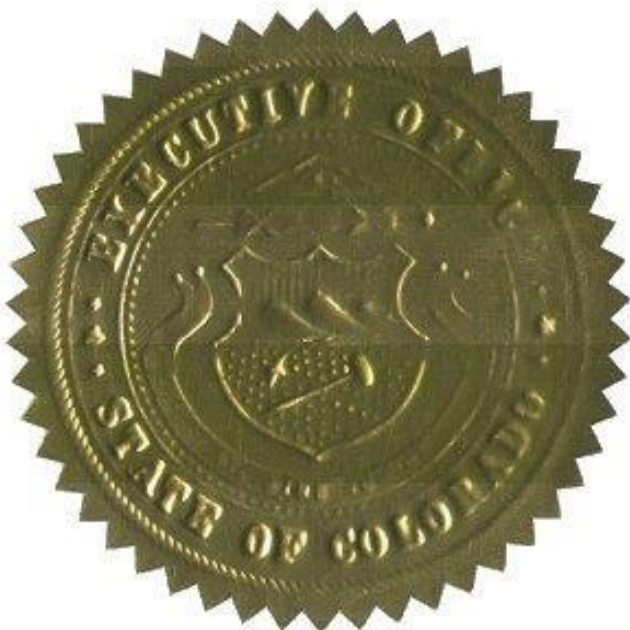

EXECUTIVE ORDER

Full and Unconditional Pardon Convictions for Possession of Two Ounces or Less of Marijuana

Pursuant to the authority vested in the Governor of the State of Colorado by Article IV, Section 7 of the Colorado Constitution and C.R.S. § 16-17-102(2), I, Jared Polis, Governor of the State of Colorado, issue this Executive Order granting full and unconditional pardons for convictions for possession of two (2) ounces or less of marijuana in the State of Colorado.

I. Background

On November 6, 2012, Coloradans passed Amendment 64, a State constitutional amendment initiated by the people of Colorado that legalized consumption or possession of limited amounts of marijuana for those twenty-one (21) years of age or older in the State of Colorado. Article XVIII, Section 16 became part of the Colorado Constitution on December 10, 2012, and legalized possessing, using, displaying, purchasing, or transporting marijuana accessories for one (1) ounce or less of marijuana.

On June 29, 2020, I signed the bipartisan House Bill 20-1424 ("HB 20-1424"), Social Equity Licensees in Regulated Marijuana. HB 20-1424 amends C.R.S. § 16-17-102 to allow the Governor to grant pardons to a class of defendants who were convicted of the possession of up to two (2) ounces of marijuana.

On October 4, 2020, I granted full and unconditional pardons to individuals convicted of possession of one (1) ounce or less of marijuana in the State of Colorado as detailed in Executive Order C 2020 004. My decision to pardon these individuals was a reflection of the law in Colorado at the time that permitted possession of one (1) ounce or less of marijuana. On May 20, 2021, I signed House Bill 21-1090 ("HB 21-1090"), which doubled Colorado's recreational marijuana possession limit to two (2) ounces of marijuana for adults twenty-one (21) and older.

Through this Executive Order, I am granting pardons for State convictions of possession of two (2) ounces or less of marijuana because possession of two (2) ounces or less of marijuana is no longer illegal in Colorado and it should not be held against people since it is not a crime.

Unfortunately, many convictions of possession of two (2) ounces or less of marijuana are municipal convictions. This Executive Order only applies to State convictions. Individuals with municipal convictions should seek a remedy on the municipal level. I also urge municipal

governments to adopt similar measures, if possible, to help individuals in line with this Executive Order.

Through this Executive Order, I grant full and unconditional pardons to a class of defendants who were convicted of the possession of up to two (2) ounces of marijuana in the State of Colorado, subject to the grant of clemency below.

II. Grant of Clemency

- A. All convictions in the State of Colorado of a petty offense, misdemeanor, or felony for possession of two (2) ounces or less of marijuana under the following statutory provisions or other relevant Colorado state statutory provisions are hereby granted a full and unconditional pardon. This Executive Order only applies to convictions of two (2) ounces or less of marijuana under state law and no other charges or convictions are pardoned by this Executive Order.

- B. For the individuals' whose convictions are pardoned by this Executive Order, all rights of citizenship associated with the pardoned conviction are restored in full without condition. All civil disabilities and public sufferings associated with the pardoned conviction are removed.

I direct the Department of Public Safety, through the Colorado Bureau of Investigation, to develop a process to indicate on criminal background checks which individuals' convictions have been pardoned pursuant to this Executive Order.
