OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY

ABC13's Disney Cruise Line Homeports TV Sweepstakes (the "Sweepstakes") is a random draw sweepstakes in which one (1) Prize winner will be randomly selected from all eligible entries received in accordance with these Official Rules to receive a prize, as described herein. By participating in the Sweepstakes, each entrant agrees that all decisions regarding the Sweepstakes, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of "Sponsor" (as defined below) and are final, binding and not subject to appeal.

I. NAME OF SPONSOR: KTRK Television, Inc., 3310 Bissonnet Street, Houston, Texas, 77005 ("ABC13" or "Sponsor").

II. ELIGIBILITY:

- Entrants must be eighteen (18) years of age or older at time of entry and be legal residents of the United States who are physically located and residing in Sponsor's viewing area, which is comprised of the counties: Harris, Fort Bend, Montgomery, Brazoria, Galveston, Liberty, Waller, Chambers, Austin, San Jacinto, Matagorda, Walker, Polk, Trinity, Grimes, Washington, Colorado, Wharton, Jackson, and Calhoun in Texas.
- Any entrants (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Sponsor, American Broadcasting Companies, Inc., Disney Destinations ("Disney") and any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year."

In addition, Sponsor may render ineligible any person who, in Sponsor's sole discretion, is sufficiently acquainted with anyone involved in the development, production or administration of this Sweepstakes.

III. HOW AND WHEN TO ENTER:

From 12:01 am Central Time ("CT") on Monday, February 5th, 2024 until 11:59 pm CT on Monday, February 19th, 2024 (the "Sweepstakes Period"), entrants may enter the Sweepstakes by visiting ABC13.com, locating the Contests & Sweepstakes section of the website, clicking on the Sweepstakes-themed link, and filling out an entry form.

You must be a registered member of ABC13.com to enter.

- Existing Member: As a Member, you may enter the Sweepstakes by logging in to ABC13.com ("Website") with your user name ("User Name") or email address ("Address") and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required to login to your Member account and participate in the Sweepstakes.
- **Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the "sign up" or similar section on the Website. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at http://disneytermsofuse.com). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the Instructions in Section III.
- By clicking the "Continue" button to continue with your entry, you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules.
- During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC13 and/or other members of the Walt Disney family of companies. Consenting to receive promotional, marketing or reminder emails is optional, does not have to be agreed to in order to be eligible to enter the Sweepstakes and does not improve your chances of winning. In the event you do consent to receive these emails, the use of such emails shall be subject to ABC's Privacy Policy, available at www.disneyprivacyCenter.com.

LIMIT ONE (1) ENTRY PER PERSON AND PER EMAIL PER DAY DURING THE ENTRY PERIOD. For purposes of these Official Rules, a 'day' is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 12:01 am CT and ending twenty-four (24) hours later at 11:59 pm CT. Sponsor is not responsible for failed, partial or garbled computer transmissions, or technical failures of any kind, including but not limited to, electronic malfunction or damage of any network, hardware, or software.

If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, other cause beyond sponsor's control that corrupt or affect the administration, security, fairness, integrity or proper conduct of the sweepstakes, sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for: any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail or electronic entry to be received on account of technical problems of traffic congestion on the internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Entries remain

the property of Sponsor and will not be returned or acknowledged. If canceled, Sponsor reserves the right at its discretion to determine the winner using all non-suspect eligible entries received up to the time of cancellation.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED: One (1) potential winner will be selected in a random drawing to be conducted on or about February 20, 2024. The potential winner will be notified on or about February 20, 2024. Odds of winning depend on number of valid entries received. The final determination of the winner is always conditional on verification of eligibility and compliance with all rules and procedures. The potential winner will be notified by the telephone or email provided on the entry form. If a potential winner cannot be reached within two (2) days of notification of winning, or if such potential winner is found to be ineligible or cannot or does not comply with these Official Rules, such potential winner will be disqualified, and an alternate winner may be selected. If the prize is not claimed by the potential winner, it will be forfeited. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go un awarded if it remains unclaimed. To claim prize, (a) winner must provide proof of age, identity, and residency, (b) winner must sign and return an affidavit of eligibility/compliance with rules, publicity/liability release and indemnification all within the time period specified by the Sponsor.

V. PRIZE:

One (1) Prize is available consisting of a Disney Cruise prize package ("**Vacation Package**") from Disney which shall consist of winner's choice of a four (4) or five (5) night Disney Cruise Line vacation for the winner and up to three (3) guests.

The Prize shall include the following:

- Parking for one (1) vehicle at Port of Galveston cruise terminal or voucher(s) for local round-trip ground transportation to and from the Port of Galveston (at the discretion of Disney Cruise Line)
- A four-(4) or five (5) night cruise on the Disney Magic for four (4) persons (exact number of nights will depend on the Cruise selected by winner), including:
 - o One (1) stateroom aboard the Disney Magic (location/category at the discretion of Disney) with a maximum occupancy of four (4) people;
 - o All meals onboard the Disney Magic (excluding specialty and fine dining)
 - o Pre-paid onboard gratuities, Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website)

Approximate retail value ("ARV") of the four (4)-night Cruise on the Disney Magic: \$4,931.88, which includes Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website).

ARV of the five (5)-night Cruise on the Disney Magic: \$5,592.16, which includes Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website).

Travel must be booked at least forty-five (45) days prior to the intended travel dates and the Prize must be taken between **March 6**, **2024**, and **March 31**, **2025**. Block Out Dates: 3/10/24 (Block Out Dates at the discretion of Disney Cruise Line and subject to change). If travel is not completed by April 5, 2025, the prize will be forfeited without compensation of any kind.

Winner is responsible for all elements of a Prize not specifically described herein, including but not limited to, round-trip transportation between the winner's residence and the port; shore excursions; travel insurance; laundry service; spa treatments; alcoholic beverages; telephone calls; ship to shore communications including fax and internet; merchandise; souvenirs; incidental expenses, parking and tips and gratuities other than listed.  limited availability, advance reservations or even closure.
