## IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, **THOMAS HENRY ROLLEII**, hereafter styled the Defendant, heretofore on or about **June 30, 2018**, did then and there unlawfully, intentionally and knowingly cause the death of Jason Ryan Maas, hereinafter called the Complainant, by stabbing the Complainant with a knife

It is further presented that in Harris County, Texas, Thomas Henry Rolle II, hereinafter styled the Defendant, heretofore on or about June 30, 2018, did then and there unlawfully intend to cause serious bodily injury to Jason Ryan Maas, hereinafter called the Complainant, and did cause the death of the Complainant by intentionally and knowingly committing an act clearly dangerous to human life, namely stabbing the Complainant with a knife.

## PROBABLE CAUSE

AFFIANT, CHRISTOPHER COOKE, IS A CERTIFIED PEACE OFFICER EMPLOYED WITH THE HARRIS COUNTY SHERIFF'S OFFICE. AFFIANT BELIEVES AND HAS REASON TO BELIEVE THAT THOMAS HENRY ROLLE II, BLACK MALE DOB: 11/16/1988, HEREAFTER CALLED THE DEFENDANT, COMMITTED THE OFFENSE OF MURDER ON JUNE 30, 2018 IN HARRIS COUNTY, TEXAS. AFFIANT BASES HIS BELIEF ON THE FOLLOWING.

AFFIANT RESPONDED TO A CALL FOR A DECEASED, ADULT MALE FOUND IN THE PARKING LOT OF CHARTWAY CREDIT UNION LOCATED AT 4373 WEST FM 1960, HOUSTON, HARRIS COUNTY, TEXAS. UPON ARRIVAL TO THE SCENE THE AFFIANT OBSERVED THE DECEDENT LYING PRONE IN THE LOT WITH EVIDENCE OF TRAUMA WHICH CAUSED BLEEDING IN THE FROM OF A BLOOD TRAIL LEADING FROM AN EMPTY PARKING SPACE AND TO THE DECEDENT WITH POOLING OF BLOOD UNDER HIS BODY.

AFFIANT SPOKE TO WITNESS TO WITNESS CASEY RUCKER WHO THE AFFIANT FOUND TO BE CREDIBLE AND RELIABLE. WITNESS RUCKER TOLD THE AFFIANT HE HAD BEEN THE DECEDENT'S ROOMATE FOR SIX YEARS. WITNESS RUCKER TOLD THE AFFIANT THE DECEDENT WAS IN THE PROCESS OF DIVORCE FROM HIS WIFE KRISTIN MAAS. WITNESS RUCKER TOLD THE AFFIANT HE KNEW KRISTIN MAAS TO BE IN A CURRENT DATING RELATIONSHIP WITH THOMAS ROLLE II WHO RUCKER KNEW BY SIGHT AND NAME. WITNESS RUCKER TOLD THE AFFIANT THE DECEDENT HAD RECENT NEGATIVE INTERACTION WITH THOMAS ROLLE II OVER A PRANK COMMITTED BY THE DECEDENT AND AN ASSOCIATE ON THOMAS ROLLE AND KRISTEN MAAS. THE PRANK COMMITTED ON THOMAS ROLLE II INVOLVED HIDING A PASSENGER CAR ROLLE AND MAAS USED AND THE THEFT OF ROLLE'S TEXAS IDENTIFICATION CARD FROM THE SAME VEHICLE. WITNESS RUCKER ADVISED THOMAS ROLLE II COMMUNICATED TEXT MESSAGE THREATS AND VOICE CALLS TO THE DECEDENT CONCERNING THE IDENTIFICATION THEFT. WITNESS RUCKER WAS AT THE SCENE OF THE CREDIT UNION AND IDENTIFIED THE DECEDENT AS JASON MAAS.

AFFIANT SPOKE TO WITNESS DAMEN DUNCAN WHO THE AFFIANT FOUND TO BE CREDIBLE AND RELIABLE AT THE TIME OF HIS INTERVIEW. WITNESS DUNCAN TOLD THE AFFIANT HE WAS PRESENT WHEN THE DECEDENT ANSWERED A PHONE CALL FROM THOMAS ROLL II AND AGREED TO MEET ROLLE IN THE LOT OF HIS MOTEL IN ORDER TO RETURN THE STOLEN IDENTIFICATION TO ROLLE. WITNESS DUNCAN TOLD THE AFFIANT HE WATCHED THE DECEDENT LEAVE HIS MOTEL ROOM TO MEET ROLLE AND NOT RETURN.

AFFIANT SPOKE TO WITNESS DONOVAN BURK WHO THE AFFIANT BELIEVED TO BE CREDIBLE AND RELIABLE AT THE TIME OF HIS INTERVIEW. WITNESS BURK TOLD THE AFFIANT HE KNEW THOMAS ROLLE II BY NAME AND SIGHT AND

WAS ALSO A TARGET OF THE THREATS ISSUED BU ROLLE OVER THE PRANK AND THE IDENTIFICATION THEFT. WITNESS BURK TOLD THE AFFIANT HE SPOKE TO A FRIEND NAMED ASHLEY TORRES WHO SAW THOMAS ROLLE AT HER APARTMENT AFTER THE DECEDENT LEFT HIS APARTMENT AND BEFORE THE DISCOVERY OF THE DECEDENT'S BODY IN THE CREDIT UNION PARKING LOT. WITNESS BURK TOLD THE AFFIANT THOMAS ROLLE CAME TO HER APARTMENT LOCATED AT 2901 FULTON #463 AND CONFESSED TO STABBING THE DECEDENT.

AFFIANT SPOKE WITH WITNESS ASHLEY TORRES AND FOUND HER TO BE CREDIBLE AND RELIABLE. WITNESS TORRES TOLD THE AFFIANT THOMAS ROLLE WHO SHE KNEW AS THOMAS OR "TOM CAT" CAME TO HER APARTMENT WHILE ACCOMPANIED BY A FEMALE WHO MATCHED THE DESCRIPTION OF KRISTIN MAAS. WITNESS TORRES TOLD THE AFFIANT THOMAS ROLLE II TOLD HER HE STABBED A GUY BECAUSE THE GUY PLAYED A PRANK ON HIM AND TOOK HIS IDENTIFICATION. WITNESS TORRES TOLD THE AFFIANT THOMAS ROLLE II TOLD HER THE GUY HE STABBED WAS DEAD AND SHE WOULD SEE THE EVENT ON THE NEWS. WITNESS TORRES TOLD THE AFFIANT SHE PROVIDED BLEACH TO THOMAS ROLLE II AND WATCHED HIM TRY TO CLEANSE BLOOD STAINS FROM HIS CAR AND A FOLDING KNIFE. WITNESS TORRES TOLD THE AFFIANT THOMAS ROLLE II DISCARDED THE KNIFE AFTER LEAVING HER SIGHT ON FOOT FOR APPROXIMATELY 10 MINUTES. WITNESS TORRES TOLD THE AFFIANT THOMAS ROLLE GAVE HER A BLOOD STAINED FIREARM HE SAID HE USED TO STRIKE THE GUY HE STABBED. WITNESS TORRES TOLD THE AFFIANT THOMAS ROLLE II ASKED HER TO BROKER THE SALE OF THE BLOOD STAINED FIREARM FOR FUNDS HE WOULD USE TO LEAVE TOWN AND AVOID THE POLICE.

AFFIANT SPOKE TO WITNESS PREDRO RIVERA THE COMMON-LAW SPOUSE OF WITNESS ASHLEY TORRES AND FOUND HIM TO BE A CREDIBLE AND RELIABLE PERSON AT THE TIME OF THE INTERVIEW, WITNESS RIVERA TOLD THE AFFIANT HE ALSO OBSERVED THOMAS ROLLE II TRY TO CLEANSE HIS CAR AND KNIFE OF BLOOD WITH A RAG AND BLEACH HE AND TORRES PROVIDED.

AFFIANT'S PEER INVESTIGATOR A. MANZANO PREPARED THREE SETS OF RANDOMIZED PHOTO ARRAYS THAT INCLUDED AN IMAGE OF THOMAS ROLLE II AND FIVE OTHER MALES WITH SIMILAR FEATURES. AFFIANT PRESENTED THE ARRAYS IN THE BLINDED ADMINISTRATOR MANNER TO WITNESS ASHLEY TORRES WHO POSITIVELY IDENTIFIED THOMAS ROLLE II AS BEING THE SAME PERSON WHO TOLD HER HE STABBED A GUY OVER A PRANK AND NEEDED BLEACH TO CLEAN THE CAR HE WAS DRIVING WITNESS TORRES ALSO POSITVELY IDENTIFIED THOMAS ROLLE II AS ASKING HER TO BROKER THE SALE OF A BOOD STAINED FIREARM FOR CASH CURRENCY.

WITNESS RIVERA POSIVELY IDENTIFIED THOMAS ROLLE II AS BEING THE SAME MALE HE PROVIDED BLEACH TO FOR THE CLEANSING OF BLOOD FROM THE CAR HE DROVE AND A KNIFE HE DISCARDED AT AN UNKNOWN LOCATION.

WITNESS DONOVAN POSITVELY IDENTIFIED THOMAS ROLLE II AS BEING THE SAME MALE WHO THREATENED THE DECEDENT BY WAY OF PHONE AND TEXT CONCERNING THE PRANK BASED ON IDENTIFICATION CARD THEFT.

AFFIANT SPOKE TO PEER INVESTIGATOR JACK FERRELL WHO OBSERVED THE REMOVAL OF THE DECEDENT FROM THE CRIME SCENE LOCATED AT 4373 WEST FM 1960, HOUSTON, HARRIS COUNTY TEXAS BY AN INSTITUTE OF FORENSIC SCIENCES INVESTIGATOR PEER INVESTIGATOR FERRELL TOLD THE AFFIANT THE DECEDENT HAD SUSTAINED AT LEAST TWO WOUNDS TO THE UPPER TORSO WHICH HAD THE APPEARANCE AND DESIGN OF STAB

WOUNDS.
