

## **ABC13's Disney Wish Cruise Sweepstakes**

### **OFFICIAL SWEEPSTAKES RULES**

#### **NO PURCHASE NECESSARY**

ABC13's Disney Wish Cruise Sweepstakes (the "Sweepstakes") is a random draw sweepstakes in which one (1) Prize winner will be randomly selected from all eligible entries received in accordance with these Official Rules to receive a Vacation Package for themselves and up to three (3) guests, as described herein.

By participating in the Sweepstakes, each entrant agrees that all decisions regarding the Sweepstakes, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of "Sponsor" (as defined below) and are final, binding and not subject to appeal.

**I. NAME OF SPONSORS:** KTRK Television, Inc., 3310 Bissonnet Street, Houston, Texas, 77005 ("ABC13" or "Sponsor").

#### **II. ELIGIBILITY:**

- Entrants must be eighteen (18) years of age or older at time of entry and be legal residents of the United States who are physically located and residing in Sponsor's viewing area, which is comprised of the counties of Harris, Fort Bend, Montgomery, Brazoria, Galveston, Liberty, Waller, Chambers, Austin, San Jacinto, Matagorda, Walker, Polk, Trinity, Grimes, Washington, Colorado, Wharton, Jackson, and Calhoun in Texas.
- Any entrants (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Sponsor, American Broadcasting Companies, Inc., and any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year."

In addition, Sponsor may render ineligible any person who, in Sponsor's sole discretion, is sufficiently acquainted with anyone involved in the development, production or administration of this Sweepstakes.

#### **III. HOW AND WHEN TO ENTER:**

From **12:01 am** Central Time ("CT") on **Monday, July 11th, 2022**, until **11:59 pm CT** on **Friday, July 29th, 2022**, entrants may enter the Sweepstakes by visiting ABC13.com, locating the Contests & Sweepstakes section of the website, clicking on the Sweepstakes-themed link, and filling out an entry form.

**How to register:** You must be a registered member of [ABC13.com](http://ABC13.com) to enter.

- **Existing Member:** As a Member, you may enter the Sweepstakes by logging in to ABC13.com ("**Website**") with your user name ("**User Name**") or email address ("**Address**") and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required to login to your Member account and participate in the Sweepstakes.
- **Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the "sign up" or similar section on the Website. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at <http://disneytermsofuse.com>). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the Instructions in Section III.
- By clicking the "Continue" button to continue with your entry, you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules.
- During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC13 and/or other members of the Walt Disney family of companies. Consenting to receive promotional, marketing or reminder emails is optional, does not have to be agreed to in order to be eligible to enter the Sweepstakes and does not improve your chances of winning. In the event you do consent to receive these emails, the use of such emails shall be subject to ABC's Privacy Policy, available at [www.disneyprivacyCenter.com](http://www.disneyprivacyCenter.com).

**LIMIT ONE (1) ENTRY PER EMAIL PER DAY DURING THE ENTRY PERIOD.** Sponsor is not responsible for failed, partial or garbled computer transmissions, or technical failures of any kind, including but not limited to, electronic malfunction or damage of any network, hardware, or software.

If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, other cause beyond sponsor's control that corrupt or affect the administration, security, fairness, integrity or proper conduct of the sweepstakes, sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for: any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail or electronic entry to be received on account of technical

problems of traffic congestion on the internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. Entries remain the property of Sponsor and will not be returned or acknowledged. If canceled, Sponsor reserves the right at its discretion to determine the winner using all non-suspect eligible entries received up to the time of cancellation.

**IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED:** One (1) potential winner will be selected in a random drawing to be conducted on or about **August 1, 2022**. The potential winner will be notified on or about **August 1, 2022**. Odds of winning depend on number of valid entries received. The final determination of the winner is always conditional on verification of eligibility and compliance with all rules and procedures. The potential winner will be notified by the telephone or email provided on the entry form. If a potential winner cannot be reached within two (2) days of notification of winning, or if such potential winner is found to be ineligible or cannot or does not comply with these Official Rules, such potential winner will be disqualified, and an alternate winner may be selected. If the prize is not claimed by **August 3, 2022, at 5:00 pm CT (or such other time as designated by Sponsor)**, it will be forfeited. To claim prize, (a) winner must provide proof of age, identity, and residency, (b) winner must sign and return an affidavit of eligibility/compliance with rules, publicity/liability release and indemnification all within the time period specified by the Sponsor.

**V. PRIZE(S):**

One (1) Prize is available consisting of a Disney Cruise prize package ("Vacation Package") from Disney Destinations ("Disney") which shall consist of a four (4)-night Disney Cruise Line vacation for the winner and up to three (3) guests.

The Prize shall include the following:

- Four (4) roundtrip coach airfares between a major gateway airport close to the Prize winner's residence (as determined at the sole discretion of Sponsor) and Orlando International Airport in Orlando, FL
- Round trip ground transportation from the Walt Disney World Resort to Port Canaveral, FL, and from Port Canaveral, FL to the Orlando International Airport;
- A four-(4) night Cruise on the Disney Wish for four (4) persons, including:
  - One (1) stateroom aboard the Disney Wish (location/category at the discretion of Disney Cruise Line) with a maximum occupancy four (4) people;
  - All meals onboard the Disney Wish (excluding Palo Steakhouse and the adult-exclusive Fine Dining – Enchanté by Chef Arnaud Lallement)
  - Pre-paid gratuities, Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website)
- One (1) standard room with a maximum occupancy of four (4) persons at a Walt Disney World Resort Hotel (resort selection at the discretion of Disney Cruise Line) for one (1) night prior to the ship's departure; and
- Motor coach transportation for four (4) passengers from the Orlando International Airport to a Walt Disney World Resort;

**Approximate retail value ("ARV") of the Prize: \$9,028.56, which includes Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website).**

The Prize must be taken between **September 2, 2022**, and **October 27, 2023**. Block Out Dates: **11/21/22; 12/19/2022; 12/26/2022; 02/20/23; 03/13/23; 03/20/23; 04/03/23; 04/10/23; 05/29/23** (Block Out Dates at the discretion of Disney Cruise Line and subject to change).

The Prize Winner and their guests (each a "Guest"; collectively "Guests" and together with the winner, the "Group") must travel together on the same itinerary, (as defined below), as chosen by Disney. Once selected by Prize winner, Guests cannot be changed without the express consent of Disney, which may be withheld for any reason.

Minors under the age of eighteen (18) not traveling with a parent or legal guardian must be accompanied by an adult over the age of twenty-one (21) in the same stateroom. The parent or guardian of any minor not traveling with a parent or guardian must appoint an adult to have custody and control over their minor and to contract on their behalf in connection with the Vacation Package. An appointment form will be included in the document package and must be signed by parent or legal guardian prior to embarkation at the Disney Cruise Line terminal.

The Prize winner and Guests are responsible for providing proper citizenship documentation to travel which may include passports, valid alien registration card and/or necessary visas. Those without proper citizenship documentation will be denied boarding. It is the Guests' responsibility to check with their travel agent, government agencies, embassies or consulates prior to participation in the Vacation Package to ensure that they have proper citizenship documentation. U.S. Citizens can also visit the State Department's travel website at [www.travel.state.gov](http://www.travel.state.gov), or call the U.S. National Passport Information Center at (877) 4USA-PPT for more information. Guests of all ages are strongly encouraged to obtain passports.

The Prize winner and their Guests will be required to execute a liability/publicity/COVID-19 release and waiver form prior to booking of any travel. Failure to return the executed release form within the specified time period will result in forfeiture of the Vacation Package. Prize winner acknowledges that they are solely responsible for any actions, claims or liabilities of the Group, related to any use or misuse of the prize or any prize-related activity or travel. There may be specific instructions and requirements for all visitors to any travel destinations, which may include mandated quarantine or pre-travel testing. The Prize winner and their Guests are solely responsible at their own cost for staying updated on and complying with any of the latest advisories and restrictions.

Winner is responsible for all elements of a Prize not specifically described herein, including but not limited to, round-trip transportation between the winner's residence and the port; shore excursions; travel insurance; laundry service; spa treatments; alcoholic beverages; telephone calls; ship to shore communications including fax and internet; merchandise; souvenirs; incidental expenses, parking and tips and gratuities other than listed. Guests must sign and return a Travel Companion Liability/Publicity Release prior to travel. Winner and guests may be required to provide Sponsor with a copy of their passport prior to ticketing of the prize. ARV for prizes may vary depending upon points of departure and destination and fare fluctuations. Winner will not receive cash or any other form of compensation if the actual value of the Prize is less than the prize ARV in these Official Rules. In the event Prize winner and/or their Guest(s) engage in behavior that (as determined by Sponsor in its sole and absolute discretion) is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the trip or other applicable experience early, in whole or in part, and send winner and/or his or her guest(s) home with no further compensation. Vacation Package must be taken on dates designated by Sponsor. Sponsor will not replace any lost or stolen tickets or travel vouchers. Prize may not be sold, traded, transferred, refunded, commissioned or redeemed for cash value. Prize elements may not be substituted and vacations are non-commissionable. Prize will be awarded only if the potential winners fully comply with these Official Rules. Prize is non-assignable and nontransferable. All details and other restrictions of prizes not specified in these Official Rules will be determined by Sponsor in its sole discretion. No cash alternative or substitution of prize allowed, except that Sponsor reserves the right in their sole discretion to substitute prize of comparable value if a prize is unavailable, in whole or in part, for any reason.

NOTE: Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more. If the Winner is unable to accept the Prize for any reason, the Prize will be forfeited in its entirety and will be awarded to an alternate winner, provided sufficient time remains.

**VI. RELEASES:** By participating, entrants agree to be bound by these official rules and the decisions of the Sponsor, which shall be final in all respects. By participating in the Sweepstakes and/or accepting any prize that they may win, entrants agree to release Sponsor, Disney, and their respective parent, subsidiary, affiliated and successor companies, advertising and promotion agencies and prize suppliers, and each of their respective officers, directors, agents, representatives and employees, as well as each of their respective successors, representatives and assigns (collectively, the "Released Parties") from any and all actions, claims, injury, loss or damage arising in any manner, directly or indirectly, from participation in the sweepstakes and/or acceptance or use of the prize. Entrants authorize the Released Parties to use their name, voice, likeness, biographical data, city and state of residence, entry materials and any materials collected by Sponsor as part of awarding the prize in programming or promotional material, in any media now known or hereafter created or conceived, worldwide in perpetuity, or on a winner's list, if applicable, without further compensation unless prohibited by law. Sponsor is not obligated to use any of the above-mentioned information or materials but may do so and may edit such information or materials, at Sponsor's sole discretion, without further obligation or compensation.

**VII. MISCELLANEOUS; WINNERS' LIST:**

**VOID WHERE PROHIBITED.** All federal, state, and local laws and regulations apply.

Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process and to cancel, terminate, modify and/or suspend the Sweepstakes in the event of tampering or other circumstances, including but not limited to acts of God or civil disturbance that render it impractical or impossible to complete or fulfill the contest as originally planned.
