## **ABC13's Disney Sleep and Mattress Sweepstakes**

## **OFFICIAL SWEEPSTAKES RULES**

# NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

ABC13's Disney Sleep and Mattress Sweepstakes (the "Sweepstakes") is a random draw sweepstakes in which one (1) Prize winner will be randomly selected from all eligible entries received in accordance with these Official Rules to receive a prize, as described herein. ## II. ELIGIBILITY:

- Entrants must be eighteen (18) years of age or older at time of entry and be legal residents of the
  United States who are physically located and residing in Sponsor's viewing area, which is
  comprised of the counties: Harris, Fort Bend, Montgomery, Brazoria, Galveston, Liberty, Waller,
  Chambers, Austin, San Jacinto, Matagorda, Walker, Polk, Trinity, Grimes, Washington, Colorado,
  Wharton, Jackson, and Calhoun in Texas.

## **III. HOW AND WHEN TO ENTER:**

From 12:01 am Central Time ("CT") on Monday, June 10th, 2024 until 11:59 pm CT on Sunday, June 16th, 2024 (the "Sweepstakes Period"), entrants may enter the Sweepstakes by visiting ABC13.com, locating the Contests & Sweepstakes section of the website, clicking on the Sweepstakes-themed link, and filling out an entry form.

You must be a registered member of ABC13.com to enter.

• Existing Member: As a Member, you may enter the Sweepstakes by logging in to ABC13.com ("Website") with your user name ("User Name") or email address ("Address") and password and

following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required to login to your Member account and participate in the Sweepstakes.

- Non-Member: If you are not a Member, you may become a Member free of charge by visiting the
  Website and registering by providing the requested information on the registration form through
  the "sign up" or similar section on the Website. By creating a Member account, you acknowledge
  your agreement to the Terms of Use (available at <a href="http://disneytermsofuse.com">http://disneytermsofuse.com</a>). Upon becoming
  a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the
  Instructions in Section III.
- By clicking the "Continue" button to continue with your entry, you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Sweepstakes Official Rules.
- During the registration and entry process, you may be asked to consent to receive promotional
  and marketing emails from ABC13 and/or other members of the Walt Disney family of companies.
  Consenting to receive promotional, marketing or reminder emails is optional, does not have to be

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED: One (1) potential winner will be selected in a random drawing to be conducted on or about June 17th, 2024. The potential winner will be notified on or about June 17th, 2024. Odds of winning depend on number of valid entries received. The final determination of the winner is always conditional on verification of eligibility and compliance with all rules and procedures. The potential winner will be notified by the telephone or email provided on the entry form. If a potential winner cannot be reached within two (2) days of

notification of winning, or if such potential winner is found to be ineligible or cannot or does not comply with these Official Rules, such potential winner will be disqualified, and an alternate winner may be selected. If the prize is not claimed by the potential winner, it will be forfeited. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. One (1) Prize is available consisting of a Disney Sleep and Mattress prize package ("**Prize Package**") from Disney which shall consist of a Nolah Evolution king size mattress and one (1) WiiM bedside lighted speaker.

  - Includes prize certificate from Nolah which will enable the winner to select the firmness of their mattress and have it shipped directly to their home
- One (1) WiiM lighted speaker
