# ABC13's Football Tickets Sweepstakes OFFICIAL SWEEPSTAKES RULES

#### NO PURCHASE NECESSARY.

ABC13's Football Tickets Sweepstakes (the "**Sweepstakes**") is a sweepstakes in which one (1) prize will be available via a random drawing, consisting of four (4) Tickets to the Houston Roughnecks vs. Michigan Panthers football game on May 17, 2025.

By participating in the Sweepstakes, each entrant agrees that all decisions regarding the Sweepstakes, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of "Sponsor" (as defined below) and are final, binding and not subject to appeal.

I. NAME OF SPONSOR: KTRK Television, Inc., 3310 Bissonnet, Houston TX 77005 ("Sponsor").

## II. ELIGIBILITY:

The Sweepstakes is open only to entrants who are eighteen (18) years of age or older at time of entry and are legal United States residents who reside in the Designated Market Area ("**DMA**") of Sponsor, as determined by Nielsen Media Research Services. The DMA of KTRK Television covers the following counties in Texas: Harris, Fort Bend, Montgomery, Brazoria, Galveston, Liberty, Waller, Chambers, Austin, San Jacinto, Matagorda, Walker, Polk, Trinity, Grimes, Washington, Colorado, Wharton, Jackson and Calhoun.

("Website") with your user name ("User Name") or email address ("Address") and password
and following the entry instructions. If you login to your Member account using Facebook, you will

be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your Member account and participate in the Sweepstakes.

- **Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the "sign up" or similar section on the Website. **IV. HOW AND WHEN WINNER WILL BE SELECTED AND NOTIFIED:** One (1) potential winner will be selected in a random drawing on or about May 12, 2025. Winner will be notified on or about May 12, 2025. **Odds of winning depend on number of valid entries received.** Final determination of winner is always conditional on verification of eligibility and compliance with all rules and procedures. The potential winner will be notified through the telephone number or email address associated with their Member account. If a potential winner cannot be reached within twenty-four (24) hours of notification, or if such

potential winner is found to be ineligible, or cannot or does not comply with these Official Rules, such potential winner will be disqualified and an alternate winner may be selected, time permitting.

**One (1) Prize is available.** Prize consists of four (4) admission tickets to the Houston Roughnecks vs Michigan Panthers football game on May 17, 2025 at 12:00PM at TDECU Stadium in Houston, TX ("**Event**"). Winner must pick up Prize tickets at Will Call at TDECU Stadium to claim the Prize, which does not include ground transportation to/from winner's residence and TDECU Stadium.

Approximate retail value ("**ARV**") of Prize is \$200. If the actual value of the prize is less than the stated ARV, the difference will not be awarded. Under no circumstances will a winner receive the difference between ARV and actual final value of Prize in cash.
