Hi Ted,

Here is the information we have been able to gather regarding Mr. Gadd.

Mr. Gadd's application was complete on 8/28/19. He was requesting Reimbursement. Once Mr. Gadd realized there were numerous items identified, he asked Inspection teams to leave his property.

Mr. Gadd was given another option, to transfer to Home Repair.

10/15/19 Mr. Gadd was notified that his taxes were delinquent with Harris County and Pasadena ISD.

10/17/19 Mr. Gadd submitted a Tax Payment Plan agreement with Harris County, but not Pasadena ISD.

10/22/19 Inspection and Construction Management team conducts an inspection for home repair.

10/25/19 Scope and estimated cost was completed. An issue relating to Mr. Gadd's inability to provide proof that the electrical wiring was done by a licensed electrician, resulted in discussion with Mr. Gadd regarding the decision to move forward with current wiring. This is still under review but the County will work through this matter. It is not holding up the process at this point.

Current Status: Mr. Gadd still owe Pasadena ISD taxes, or has not indicated to us that he has worked out a payment plan.
